## Sherman's Reform Ballot Measure Approved for March Ballot

Recently, the City Council voted unanimously to place my proposed charter amendment on the March 3<sup>rd</sup> 2020 Primary ballot.

As Audit Committee Chairman and a member of this year's Auditor Search Committee, it became clear that there was a fundamental flaw in the Auditor selection process.

Currently the Mayor's office appoints the City Auditor. This appointment process could create accountability issues since the City Auditor would be tasked with conducting oversight of, and holding accountable the administration.

To fix this flaw, my ballot measure, if approved by voters, would make the following changes:

- The Audit Committee vets all applicants and nominates three candidates to the full City Council
- The City Council interviews the three candidates and appoints the best qualified
- Mayoral administration not

involved in the appointment process

The City Auditor is vital to holding the city administration accountable and ensuring taxpayer dollars are spent properly. The administration shouldn't be in charge of choosing who is overseeing the administration. This ballot measure will help ensure this vital position is truly independent.

I appreciate the unanimous and bipartisan support this measure received at City Council. I am also thankful for former Councilmember Donna Frye who helped push this measure through.

I look forward to speaking with voters in the upcoming months regarding the importance of passing this measure in March of 2020.

### **Mission Valley Planning Group General Election in March**



**On Wednesday, March 4, 2020** the Mission Valley Planning Group ("MVPG") will hold a General Election of Members to serve on its Board. The General Meeting and Election will be at **Noon**, in the Community Room, Mission Valley Library, 2123 Fenton Parkway, San Diego.

### The MVPG Board represents

the General Members of the Mission Valley Planning Group and is an all-volunteer group. Its primary purpose is to advise the City Council, Planning Commission, and other governmental agencies as may be appropriate in the initial preparation, adoption of, implementation of, or amendment to the general or community plan as it pertains to the area or areas of influence of Mission Valley.

Each term is four (4) years and three (3) positions will be filled in the General Election in each of the following classifications:

- Class I: Property owner, who is an individual identified as the sole or partial owner of record, or their designee, of a real property (either developed or undeveloped) within the community planning area. *Term expires March 2024*
- **Class II:** Person (including residents or persons representing business entities) paying property taxes on any parcel of real property in the community planning area. *Term expires March 2024*
- Class III: Resident, who is an individual, whose primary address is an address in the community planning area (either an owner or renter). *Term Expires March 2024*
- Class IV: Local business person (including persons representing business entities), who is a local business owner, operator or designee, with a business address in the community at which employees or operators of the business are located. *Term expires March 2024*

## **City Seeks Input to Help Improve Livability for Older Residents**



The City of San Diego is asking for input from residents 50 and older via an online survey to help prepare for the changing needs that come with aging.

The survey, which takes approximately 10 minutes to complete, seeks input across eight topics: Outdoor Spaces and Public Places, Transportation, Housing, Social Participation, Respect and Social Inclusion, Work and Civic Engagement, Communications and

Information, and Community and Health Services.

Surveys are available in both <u>English</u> and <u>Spanish</u> and only residents of the city of San Diego are eligible to participate. The public can provide responses until December 13<sup>th</sup>.

The survey, conducted by the City's Parks and Recreation Department's AgeWell Services program, is a collaborative effort with the San Diego Foundation and San Diego State University's Social Policy Institute.

It is also part of a broader City effort in concert with the World Health Organization and the American Association of Retired Persons (AARP) to designate San Diego as a member of the global network of "Age-Friendly Cities" that embrace healthy aging, civic participation, and sustainable economic and social success.

To complement the findings of the survey, the AgeWell Services program received a \$50,000 grant from the San Diego Foundation to provide funding for future programming and materials specifically designed for older residents. The funding will help make recreation centers and other facilities welcoming and engaging to people of all ages, creating vibrant community gathering places.

The City's AgeWell Services program engages with older residents to help keep them active and healthy through schedule day trips, dances, volunteer opportunities, weekly activities, and signature annual events such as the AgeWell Talent Show, craft sale and photo and art shows, among others.

## **Donations Needed to Support Homeless Veterans**

Last year, the Allied Gardens/Grantville Community Council asked the community to welcome and support the 84 formerly homeless Veterans who took up residence at the newly renovated Zephyr building in Grantville.

What was once a rundown motel that attracted crime is now used for homeless Veterans with wraparound services to help them get their life back on track.

The Community Council is now asking for support for a new challenge. Stella, the residence that was recently opened on Twain Avenue offers permanent housing to 79 chronically homeless individuals who are working to return to a stable and productive role in society.

On-site counseling and support will be offered to by Interfaith Community Services and the Department of Veteran Affairs.

In the longer term, any donations in the form of household goods would be appreciated. However, there is an immediate need for food. Donations can be dropped off at 4304 Twain Avenue on weekdays between 9:30 am and 4:30 pm.
