

# MEETING MINUTES April 11, 2018 City Administration Building, 202 C Street, San Diego, CA

- 1) **Call to Order** Anne Fege, Chair, called the meeting to order at 11:45 a.m.
- 2) Attendees.

- 3) **Approval of Minutes.** No minutes were approved.
- 4) **Announcements and Updates**. The Board will continue to focus on staffing and budget, for the urban forestry program.
- 5) **Actions.** No official actions were taken.
- 6) Subcommittee Reports
  - a. Municipal Code and Council Policy. All sections have been drafted for the revised Street Tree Protection and Planting code. The subcommittee will meet in the next month, and bring the proposed draft to next CFAB meeting.
  - b. Website Review. Widener reported that the subcommittee has identified changes to some pages, and will continue to suggest revisions.
  - a. Urban Tree Canopy Assessment. Ashley Rosia, Widener and others are developing maps to assist community members in visualizing current trees and where trees can be planted. Puja Batra and Fege met with University of California San Diego staff from the Supercomputer Center and the Bioregional Center on March 16. UCSD has the files and will be analyzing data from many perspectives, focusing on District 8.

## 7) City Staff Reports

- a. Widener gave updates on the citywide tracking report, which is tied to the Infrastructure Asset Management System. The field tree inventory is about 95% done, and will include data on about a third of the City's trees. California Department of Forestry and Fire Protection (CalFire) has invited the City to submit final application for more tree inventory and planting.
- b. Sergio Arias reported progress on tree requests and plantings.

- c. New pests are well established in southern California, and tree mortality may be extensive. The San Diego Regional Urban Forests Council meeting on April 4 featured an update and field identification for "Invasive Shot Hole Borer... Coming to a tree near you!" More information at www.pshb.org.
- d. New Horticulturist has been selected, accepted and will start work in early May.

- b. Fege, Melious, Virginia Wilson, and Charlene Pulsonneti attended the City Council meeting on April 10, for Council approval of two appointments and seven reappointments. Five Councilmembers affirmed their commitment to tree benefits and management.
