- a. Partnerships/Finance Working Group. FY 2014 budget process, Mayor's and Council recommendations. *Discussion Item.* d'Elgin, Banfield-Weir, and Rivet attended May revised budget hearings and spoke in favor of CFAB interests when possible.

Andy Field gave the City's report. The City's consulting arborist assessed the health of the trees. Park & Recreation Dept has determined the groves to be eligible for Preservation Grove status. Bob Ilko gave a brief history of the trees in the area and provided the area planning group's input and supports the City's recommendation. Board questions and discussion of the difference between heritage and preservation requirements followed.

Action Item Approved. The Community Forest Advisory Board (CFAB) recommended designation of the olive trees generally located to the north and south of Atrium Drive and west of Aviary Drive within the City-owned parcels known as Derenbaker Park, Aviary Neighborhood Park, and Hendrix Pond in the Scripps-Miramar Ranch

Community Planning Area as a heritage tree or preservation grove per the Conserve a Tree Nomination Forms submitted pursuant to Council Policy 900-19 by the Scripps Ranch Civic Association (SRCA), Scripps Ranch Historic Preservation Society (SRHPS), and Scripps Ranch Planning Group (SRPG) (collectively called the applicants). The Grove will exist without additional MAD support. The Applicant will contribute additional maintenance funds as necessary to maintain the Grove. [C.Jones/d'Elgin]
