At the March 2020 election, Patty Vaccariello was not eligible for election due to reaching her 8 year limit. She ran on the ballot, but did not receive the needed votes to be seated. Lisa Nguyen, David Bowen, Brenda Diaz, Rose Calvario, Jose Hernandez and Juan Pablo Sanchez were not re-elected to office. Jim Varnadore, Edwin Lohr, Vanessa Erickson, Denisse Lopez, Andrew Benevides and Randy Torres-Van Vleck were elected to office and seated in April. At the May 2020 meeting, Vanessa Erickson was selected as Secretary, Edwin Lohr was selected as Second Vice-Chair, Maria Cortez was selected as First Vice-Chair and Russ Connelly was selected as Chair.

Committee Changes: In June, Rosa Calvario and Patty Vaccariello were seated by appointment to fill empty seats. In July, Hamdi Noor's Youth seat was vacated due to her graduation. In December, Dhaha Nur' School/Non-Profit seat was vacated due to lack of attendance. His seat was filled in January 2021 by Rahmo Abdi. At the end of the term, the Youth seat was still vacant due to lack of candidates coming forward to fill the seat.

Among the major actions and accomplishments of the term were: Action items including memos of input to various City Staff regarding Land Development Code updates, proposed local parking changes, Complete Communities & General Plan Updates. Three Community Input Workshops were held. (Including a session with another planning group regarding a project on an APC boundary). The committee's bylaws were reviewed and updated. Several meetings and agendas were translated in Spanish with the help of the Planning Department at the requests of the community. There was no meeting held in May 2020 due to COVID and a lack of agenda items; the September 2020 was adjourned due the meeting falling on a holiday. All 2020-2021 committee meetings were held via Zoom.
