NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT DESCRIPTION: Enter Consent to Assignment ("Consent") between The City of San Diego and CHH Torrey Pines Hotel Partners, LP. Hilton Orlando Partners III, LLC ("Assignor"), a Delaware limited liability company, desires to enter into an Assignment and Assumption of Ownership Interests ("Assignment") to sell, transfer, assign, and convey to Braemar Hospitality Limited Partnership twenty-five percent (25%) limited partnership interest in Ashford HHC Partners III LP. The Lease requires City's consent to the assignment of any portion Lessee's interest in the Lease, including the Assignment.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions listed in CEQA Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
