#### Reported out on March 6, 2007, at 5:30 p.m. by Karen Heumann, Assistant City Attorney:

The City Council voted in Closed Session to approve the proposed settlement in the *Greg Spencer, et al., vs. City of San Diego, et al.,* U.S. District Court Case No.: 04cv2314-BEN (WMc), in which the City was sued by a group of homeless advocates. The terms of the settlement include the adoption of guidelines of previously enacted by the San Diego Police Department. Pursuant to the guidelines, the San Diego Police Department may cite or arrest an individual for illegal lodging between the hours of 9:00 a.m. and 5:30 p.m. if: (1) they are responding to citizens' complaints, (2) they ask the individual to move but he/she refuses, and (3) they offer homeless services but they are refused. This settlement does not alter the San Diego Police Department's ability to respond to violations of law that occur independent of illegal lodging.
