The City Council also voted on Closed Session Item Number Three, City of Grass Valley, et al. versus Michael Cohen, et al., Case Number S246191 (California Supreme Court, December 28, 2017), to initiate or intervene in litigation. The City of Grass Valley is asking the City of San Diego to submit an amicus curiae ("friend of the court") letter in support of Grass Valley's Petition for Review to the California Supreme Court, and if granted, a brief in support of Grass Valley. Grass Valley challenges an appellate court decision regarding the authority of the California Department of Finance (DOF) to claw back certain pre-dissolution payments totaling approximately \$1 million, which DOF maintains was appropriate under the laws that eliminated redevelopment agencies throughout California in 2012.
