The City Council voted on Closed Session Item Number Three, State of California, et al. versus State of Texas, United States Supreme Court Case Nos. 19-840 and 19-1019, to join in litigation as an amicus participant supporting the Affordable Care Act. On December 18, 2019, a federal appeals court declared a portion of the Affordable Care Act (ACA) invalid and directed a lower court to decide whether the entire ACA was therefore invalid. The United States House of Representatives, the State of California, and other states successfully petitioned the United States Supreme Court to review that decision. On April 14, 2020, Santa Clara County and the City of Chicago solicited the City of San Diego to join in a local government amicus brief to be filed with the Supreme Court. The amicus brief will support the states' defense of the ACA.
