The City Council voted on Closed Session Item No. Two, *R.V.*, *et al. v. Mnuchin, et al.*, United States District Court, District of Maryland, Case No. 8:20-cv-1148, to join in litigation as an amicus participant supporting the CARES Act and to pursue any necessary future appeals in the litigation. Seven U.S. citizen children and their parents, one or both of which is an undocumented immigrant, filed suit in the District of Maryland challenging the denial of stimulus payments distributed under the CARES Act to U.S. citizen children solely based on their parents' undocumented status. Plaintiffs argue that the exclusion of these children violates the Fifth Amendment.
