- I. <u>Call to Order & Statement of Purpose+Vision</u> Commissioner Janet Poutré called the City of San Diego Commission for Arts and Culture to order at 8:46 a.m. at the City Council Committee Room, 12<sup>th</sup> Floor, City Administration Building, 202 C Street, San Diego, CA 92101. Commissioner Janet Poutré read aloud the Commission's statement of purpose and vision.
- II. <u>Non-agenda Public Comment</u>
  - Theresa Kosen (Arts & Culture San Diego Coalition) shared two examples of arts organizations that
    rganizations collaborate to strengthen our diverse cultural ecosystem. The first example was the 4<sup>th</sup>
    annual Hearing the Future Festival that occurred in January which brought together more than 15
    arts and culture organizations. The second aswas the San Diego Civic Youth Ballet collaboration
    with the San Diego Model Rail Road Museum presenting Choo Choo's in Tutu's.
  - Peter Comiskey (Balboa Park Cultural Partnership) thanked everyone who was able to attend the Annual Trustees Connected event on March 14, 2019. Mr. Comiskey shared that he is looking forward to the extended policy and funding meeting that is being planned. He also reported that the cultural districts in the state and the county and working more closely together and he will be bringing more details about this initiative to the Commission in the coming months.
  - Carol Manfield (Coral Consortion of San Diego) invited the Commission to their annual performance Saturday at the Spreckel's Theatre.

### III. <u>Chair's Reports</u>

A. <u>ACTION – January 25, 2019 Commission Meeting Minutes</u> – Commissioner Tyler Hewes made a motion to approve the Commission meeting minutes of December 21, 2018. Commissioner Ben Meza seconded the motion. The vote was 8-0-0; the motion passed.

B. <u>Other Reports</u> – Commissioner Janet Poutré reported that funding panels were conducted during the week and she thanked everyone who had attended. Poutré congratulated Peter Comiskey for the success of the recent Balboa Park Trustees Connected event, and she thanked her colleagues on the Commission who were able to attend. Poutré reported that the Mayor continues to state that the arts funding line items in the FY20 budget will not be impacted by the budget cuts that each

department has been asked to take, and that the Mayor will be declaring April asArts, Culture & Creativity Month in San Diego. Aproclamation is being planned. Finally, Poutré thanked everyone for their time and participation in the Commission Workshop.

- IV. <u>Committee Reports</u>
  - A. Policy & Funding Committee Commissioner Ann Bossler, Chair of the Policy & Funding Committee reported that Executive Director, Jonathon Glus provided an overview of FY20 arts and culture program and initiative budget priorities to the committee. Discussion topics included the allocation to Horton Plaza Theatre Foundation and with additional information on the City's obligation to fund that organization, and the annual allocations for arts and culture funding programs and arts education. There was further discussion about the need to consider the impact of the initiative for arts education enrichment. She also reported that Senior Arts and Culture Funding Manager, Gail Wingfield, presented a summary of the mid-year reports submitted by contractors. The next and likely final Special Meeting will be on May 10<sup>-</sup> 2019 from 8–9 a.m.
  - B. <u>Public Art Committee</u> Commissioner Ben Meza, Chair of the Public Art Committee presented the action items to the Commission.
    - <u>ACTION Donation of Artwork Proposal from Hal W. Goforth Jr. and Florida Track Club-West:</u> <u>Meb: Boston Strong by Jessica LoPresti and Oscar Leon</u> – Commissioner Ben Meza introduced the item and asked Chief of Civic Arts Strategies, Christine E. Jones to provide an overview of Hal W. Goforth Jr. and Florida Track Club's proposal to donate a life-size bronze sculptural depiction of Meb Keflezighi, a professional athlete and San Diego resident, to be sited either in Balboa Park or Mission Bay Park. Jones summarized the Public Art Committee recommendation to recommend to the Executive Director of the Commission not to accept the donation of artwork titled *Meb: Boston Strong* from Hal W. Goforth Jr. and Florida Track Club-West into the City of San Diego Civic Art Collection. Jones reported that the Parks and Recreation Department had also recommended that the donation not be accepted, and had encouraged the donor to approach a local high school instead.

Public Comment

Hal W. Goforth Jr. Mr. Goforth introduced himself, described his support of the donation proposal and commented on the evaluation of the proposed donation, including criteria related to artist selection, public safety and commemorative artwork of a living person.

**Commissioner Vernon Franck made a motion to not accept the donation of artwork proposal from Hal W. Goforth Jr. and Florida Track Club-West:** *Meb: Boston* **Strong by Jessica LoPresti and Oscar Leon. Commissioner Tyler Hewes seconded the motion.** Commission then discussed the proposal. Discussion topics included the relevance to the collection, the fact that the City does not ordinarily collect commemorative artwork of living persons, clarification that the proposed artwork hasn't been fabricated yet, and acknowledgement of Meb's athletic achievement. Commissioner Franck shared that proposed artwork donations come in different forms and accession criteria are considered for all proposals. Alternate locations with stronger relationship to site were suggested such as San Diego High School, Meb's alma mater. Commissioner Blevins expressed how important Meb is to the district he is from. (District 4) Commissioner Meza shared that San Diego High School is currently remodeling the facility and it would be a great opportunity for the donation. **The vote was 8-0-0; the motion passed.**

She is a member of numerous committees at the school including Academic Senate, Honors Program, and Academic Program Review Committee. She is a contributing author of Queering Asian American Art published by Duke University Press. Dr. Park has presented in several art history conferences regarding contemporary Asian American Art and socially engaged art practices and pedagogy. Dr. Park has over 10 years of exhibition experience in varying capacities such as lead curator for Civil Space: L.A. Riots at the Museum of Tolerance for the 20th anniversary of the 1992 L.A. Riots and Curatorial Director for compactspace gallery in Los Angeles. She received her BA in art history from the University of California, Los Angeles, MA from San Francisco State University, and her Ph.D. in art history, theory, and criticism from the University of California San Diego.

### IV. <u>Welcome</u>

- A. Opening Comments Janet Poutré, Chair, thanked Connect and Commissioner Smith for obtaining the venue space for the workshop to take place along with thanking the Commissioners in attendance and looked forward to the progress that would be made during the workshop.
- B. Opening Comments Jonathon Glus, Executive Director, echoed Commissioner Poutré's thank you's. The team has been working on building and refining proposed agendas and is looking forward to the strong leadership skills of Danell in moving the workshop forward.
- C. Agenda Overview Danell Scarborough, Facilitator, welcomed everyone and thanked everyone for taking the time out of their day to be at the workshop.
- V. <u>Introductions and Opening Exercise</u> Facilitator Scarborough opened with introductions from all in attendance with an opening exercise called, "If you really knew me, you would know..." in order to cover the relationship building objective for the workshop. Each person within the room shared something personal about themselves with everyone. "Why do you dedicate your time to be in the Commission?" Each person within the room expressed their love for the arts and that it had been engrained in them since their youth. To help the conversation flow, the brochure from the National Conflict Resolution

Center was introduced regarding Inclusive, Listening to Understand, Showing Respect for Ideas, Explaining our Perspectives Fairly, Not Engaging in the Things that Distract Us.

- VI. <u>2018 Accomplishments</u> Based from the survey that had been sent out to Commissioners and staff, the information that had been obtain from it all was that spirit was kept alive while putting the civic art collection online. Contracting and funding issues were addressed while also conducting outreach, advocacy, and awareness events. Management continued to persevere during a year of changes and onboarding of a New Executive Director.
- VII. <u>Mission, Roles and Responsibilities</u> Discussion was made of what the mission, roles and responsibilities are of the Mayor, City Council, Commissioners, Contractors, Artists, Community, Executive Director and Staff. Mayor: be present, advocate, listen, support, devote sustainable financial resources, promote STEAM, represent the Commission. City Council: see arts and culture as integrated, listen at a granular level, put arts and culture into budget memos, prioritize, communicate with us, believe, invite us. Commissioners: influence, inspire, demonstrate/leverage value and relevance of the arts, invite to events, connect, partner, conduct updates in district-meet and greets, ask, teach to improve, listen, be present, engage, mentor, matchmaking/bridging. Contractors: create, listen, deliver, advocate, appreciate, expand, invite. Artists: create and thrive. Community: self-advocate, consume, participate, support working artists, contribute, converse. Executive Director and Staff: keep it moving/in action, listen, represent, develop programs and political support, support vision of Commissioners, provide focus and consistency, engage nationally, bring professional expertise, co-create with Commissioners whoo bring local insight, track every opportunity, use best practices, develop partners and allies in City Hall, provide guidance and framework, execute, be a timekeeper, be a resource for information, be an ombudsperson.

- IX. 2019 Programming Trends and Ideas – Executive Director, Jonathon Glus shared a presentation on the workplan overview for the Commission. The workplan overview from now until July 2019: continue to onboard new team members, facilitate FY20 OSP/CCD RFP evaluation panels, continue to refine arts and culture funding program, promote April as Arts, Culture and Creativity Month, launch digital arts marketing boot camp/pre-Nonprofit Academy, preparation for FY20 Arts Education Enrichment Initiative, "meet the new team" event in May. Workplan overview from July 2019 to December 2020- Funding and Technical Assistance: assess Arts Education Enrichment Initiative for impact/outcome with arts education partners, identify opportunities to augment Nonprofit Academy to include marketing, research aspirational funding categories-marketing, micro, artists, equity, etc., continue to refine OSP/CCSD funding program, continue to survey contractors and potential contractors for additional technical assistance needs and provide as possible. Public Art: develop and update toolkits, application forms, etc., launch second iteration of "Here Comes the Neighborhood" public art project, launch "San Diego Sites" public art project. **Communications:** overhaul website, relaunch social media presence, refine brand, research communications platform for field, implement webinars, videos, etc., training and informationaccess tool, expand staff engagement with community, including "coffees", topical roundtables, informational gatherings, etc. New Projects and Initiatives: launch Civic Poet, launch Public Art Bootcamp, research new artist opportunities such as acquisition program, artist exchanges, etc., research continued and enhanced binational program, create cultural presence at City Hall and key city facilities, research artist in residence opportunities inside city departments but in accessible sites. Targeted Assessments: Cultural Tourism with Tourism Authority, Creative Economy with San Diego Regional Economic Development Corporation, Equity assessment with the Commission for Arts and Culture. **Cultural Plan Prep**: stabilize agency anchor programs, educate internal and external stakeholders on cultural planning process, conduct aforementioned assessments to inform planning process.
- X. <u>Commission Effectiveness</u> Discussion was made of what transparency in action and building influence means for the effectiveness of the Commission. In **Transparency**: we are good, clarity of vision and buy in, we can work within parameters of the Brown Act, we can promote feelings of trust, safety, and value for all involved. In **building influence**: we can talk about the Commission in all spaces we work within, wear our nametags, be present in the community, be intentional regarding engagement of key people, tap the press to capture this new day, make events readily available; digital platform/link with tourism, partner with other groups; work smarter, link with regional resources; with schools and their performing arts programs; with the County, partner with Commission on Gang Prevention and Intervention/Policy-Community Relations Board on arts projects and jobs, document how arts are life changing; assess in genuine manner arts impact and return on investment, infuse arts and culture into other nonprofits'

### POLICY & FUNDING COMMITTEE RECOMMENDATION

Recommend to the City of San Diego Mayor and City Council the Request for Proposal ranks for FY20 Organizational Support Program and Creative Communities San Diego funding categories, as submitted by Commission Advisory Panelists, and ask Commission staff to come back with further input on funding organizations outside the city limits.

### SUMMARY

The City of San Diego (City) issued the Request for Qualifications (RFQ) for FY20 Organizational Support Program (OSP) and Creative Communities San Diego (CCSD) funding categories on September 19, 2018. One hundred sixty-six (166) nonprofit organizations submitted an application in response to the RFQ. Of those applicants, one hundred sixty-three (163) were scored as qualified and asked to submit a proposal in response to the Request for Proposal (RFP). All qualified first-time applicants were required to submit a proposal; qualified applicants under contract with the City for FY18 and FY19 OSP and CCSD funding were able to select between submitting a proposal and requesting that the City exercise the Option to Renew their agreement. In total, forty-seven (47) proposals were submitted in response to the RFP and one hundred thirteen (113) requests to exercise the Option to Renew were received. Of the 47 proposals reviewed, forty-six (46) received a score high enough to qualify for funding (a minimum of 3-). No applicant submitted an appeal. Organizations who were granted the Option to Renew agreed to retain their ratified rank from the previous year. NOTE: three of the numbers above have been modified from the staff report submitted to the Policy & Funding Committee on April 11, 2019. Total applications submitted were 167, not 166 as earlier stated, 163 applications were scored as qualified, not 164 as earlier stated, and 113 requested the Option to Renew, not 116 as earlier stated.

In January 2019, the Commission for Arts and Culture (Commission) appointed Commission Advisory Panels (CAP) to participate in the review of proposals received by the City for the FY20 OSP and CCSD funding categories. Over a one-week period, CAPs convened in four separate public meetings. Each panel evaluated a specific group of proposals using standard criteria and scoring. The panels also included a process piloted in FY18 allowing applicants to address the panel at two prescribed intervals – prior to and following the panel discussion of each applicant's proposal. After evaluation of all proposals and scoring, each CAP voted to recommend ranks for their specific group of proposals. The lists included with this report show all qualified applicants, including the recommended ranks provided by the FY20 CAPs and ranks retained by applicants who were granted the Option to Renew.

On April 12, 2019, the Commission's Policy & Funding Committee's (Committee) task was to make a recommendation to the Commission regarding the FY20 OSP and CCSD RFP ranks and awards. The Committee also asked Commission staff to come back with further input on funding organizations outside the city limits. The vote for the Committee's recommendation above was 5-0-0.

### NEXT STEPS

Following the Commission's recommendation, the RFP ranks will be recommended to the Mayor and City Council. Commission staff will use the recommended rank as one factor in the calculation of each applicant's contract award amount, using the standard award algorithm as stated in the FY20 OSP Funding Guidelines and FY20 CCSD Funding Guidelines. Tentative award amounts will be shared with applicants as they are available, and final award amounts will be announced by June 30, 2019.

### PUBLIC ART COMMITTEE RECOMMENDATION:

Recommend that the Executive Director of the City of San Diego Commission for Arts and Culture (Commission) accept the final artwork proposal by Miki Iwasaki in fulfillment of the City of San Diego's (City) collecting mission, collection scope and accession criteria as established in Section 5 – Collecting Mission, Section 6 – Scope of the Collection and Section 8.2 – Accession Criteria of the Commission for Arts and Culture Department Instruction 1.00 – *Collection Management Policy for the Civic Art Collection*.

### SUMMARY:

Artist Miki Iwasaki was commissioned to design, fabricate and transport permanent, site-specific artwork for Children's Park and consult during installation of artwork at the site by the City. The Children's Park project involves major improvements to the existing park in the Marina area of Downtown. Schmidt Design Group produced the general development plan, and Spurlock Landscape Architects are the architects for design improvements to the park located between Martin Luther King Promenade and West Island Avenue in Downtown. The artist has collaborated with Spurlock Landscape Architects.

On November 2, 2018, Iwasaki presented his preliminary artwork idea to the Public Art Committee (PAC) for feedback. PAC also provided feedback on the artist's schematic artwork proposal on January 4, 2019. On April 3, 2019, the artist's final artwork proposal was presented to PAC. At the meeting, PAC voted (5-0-0) to recommend to the Commission that the Executive Director of the Commission accept the final artwork proposal by the artist in fulfillment of the City's collecting mission, collection scope and accession criteria. In addition to PAC's feedback, the final artwork proposal is informed by suggestions from the public, the City's Parks and Recreation Department, and other various City departments.

### FISCAL CONSIDERATIONS:

This project is funded by the City of San Diego as set forth in City of San Diego Council Policy 900-11 - Inclusion of Public Art in Selected Capital Improvements Program Projects.

The final design for *Petrichor* consists of large tube steel space frames that define three interlocking abstract volumes 'floating' above the ground plane. The organization of the frame was shaped as a faceted geometry where the faces were closed with additional thinner tube steel members. The result is that the outer 'skin' of the volumes begin to carry many visual properties simultaneously. Depending on the lighting conditions, proximity, perspective and peripheral objects the volumes can change from solid objects, to translucent screens and create shadow play on the adjacent surfaces.

The placement of the piece, as recommended by the landscape architect, is positioned between the fountain and the children's play structures. This placement allows for an isolated yet contextually strong position within the park. It allows for its own isolated experience as a public art element while also cognitively reading its relationship to the other elements within the park.

The vertical steel supports holding up the forms also direct your view upward into the piece. The irregularity of the support spacing also forces the viewer to slowly navigate underneath it allowing for a more deliberate experience. The groundcover and hardscape is designed as a continuation of the cloud and can be interpreted as landforms or bodies of water on the ground. The ground material will be gravel which will float over the actual foundations for the vertical steel supports. The contextual materials of the landscaped pathway, decomposed granite and turf areas will fill in around the ground surfaces.

The steel forms and steel vertical supports will be welded and mechanically fastened in manageable parts appropriate for fabrication and installation. All the steel and hardware will have a zinc coating for durability and an additional white marine paint top coating which allows the ambient light conditions to interact more vividly with the piece.

The intention is to also have in-ground lighting that will illuminate the object in the evening. This will allow for the piece to be a beacon in the forest and be visible from multiple vantage points in and beyond the park boundaries. The illuminated piece can be enjoyed by pedestrians, automobiles, mass transit passengers, local residents and hotel guests.
