At its April 24, 2018 open meeting, the CRB made a recommendation to SDPD that SDPD establish a policy that would prohibit officers from viewing surveillance videos or body worn camera videos of other officers prior to being interviewed by Internal Affairs.

Action Item Status: SDPD has not reached a decision on this recommendation.

- I. Call to Order: Policy Committee Chair Brandon Hilpert called the meeting to order at 4:11 p.m.
- **II. Purpose of the Policy Committee:** Committee Chair Hilpert waived the reading of the purpose of the Policy Committee.
- **III.** Non-Agenda Public Comment: CRB 2<sup>ND</sup> Vice Chair Taura Gentry commented that she went on the Community Bus Tour and SDPD is using the American sign language interpreters in the field. 2<sup>nd</sup> Vice Chair Gentry stated that the Committee should consider creating a

policy or procedure to incorporate American sign language interpreters for SDPD officers in the field. She agreed to fill out and submit a CRB Policy Committee referral form to support her request.

IV. Approval of August 13, 2019 Committee Meeting Minutes: Community Review Board on Police Practices (CRB) Chair Joe Craver moved for the Policy Committee to approve the meeting minutes of August 13, 2019. CRB 2<sup>nd</sup> Vice Chair Taura Gentry seconded the motion.

The motion passed with a unanimous vote of 8-0-0.

- V. Unfinished Business (Discussion/Action)
  - a. Procedure & Guideline for SDPD Complaint Intake of Informal/Formal Complaints (Committee Chair Brandon Hilpert)

Committee Chair Hilpert stated Internal Affairs were going to present the Policy Committee with an update regarding formal and informal complaints. Captain Morris of SDPD Internal Affairs stated that the SDPD Policy and Procedures for the complaint intake process is outdated (June 5, 2015), and currently it has been rewritten and undergoing review. Captain Morris stated there has been language added to the policy.

This item was tabled.

 b. Modify SDPD Procedure 1.49: Axon Body Worn Cameras (BWC) – Section Q 7(N) (Committee Chair Brandon Hilpert)

2<sup>nd</sup> Vice Chair Taura Gentry reported that she discussed this concern with the member of the public who submitted the recommendation. The community member stated that a complainant should be able to have a support person with them while he or she is viewing the BWC footage of his or her incident. SDPD Internal Affairs has discretion to allow this to happen during interviews. The community member believes there should be parameters or guidelines in place that should be discussed with the complainant before he or she selects an individual to be his or her support person. Committee Chair Hilpert stated that there should be flexibility in the procedure and this applies to a specific case. Captain Morris stated there is not an issue with allowing a support person during interviews. However, due to respecting the privacy of the parties involved, the only persons who can view the BWC is the complainant, the officer(s) and those who are directly involved in the incident. 2<sup>nd</sup> Vice Chair Gentry stated she will sponsor this recommendation and work with Internal Affairs to come up with language to add to this policy and procedure.

This item was tabled.

## c. Development of Third-Party Mediation (Nancy Vaughn)

Committee member Nancy Vaughn shared what she learned during the National Association for Civilian Oversight of Law Enforcement Conference (NACOLE). Committee member Nancy Vaughn stated that there were several cities representing Police Departments that have mediation programs. The mediation programs are staffed independently by their oversight boards with trained staff. It is not staffed by the Police Department. Committee member Nancy Vaughn stated the CRB does not have the funding or the staff to support a mediation program, however, it is something that is much needed in the City of San Diego.

Committee Chair Brandon Hilpert suggested tabling this item until after the election, to ensure that the CRB Policy Committee will have a better idea of what recommendations to make.

This item was tabled.

### d. Best Practices Research for Law Enforcement Investigations Involving Discrimination Allegations (Patrick Anderson)

Committee member Patrick Anderson was not in attendance. Committee Chair Brandon Hilpert reported that member Patrick Anderson will provide handouts of his research during the next Policy Committee meeting, scheduled for November 12, 2019 to support the discussion for this topic.

CRB Executive Director, Sharmaine Moseley reported that this topic was covered at the NACOLE Conference. She suggested

scheduling a special meeting with the Board about lessons learned during the NACOLE Conference and include this item.

This item was tabled.

### e. Complaint Process Guide Card Issued to All Sworn Personnel (Taura Gentry)

The development of the Complaint Process Guide Card was discussed. 2<sup>nd</sup> Vice Chair Taura Gentry stated that she has an example of the complaint card, but it is located in her old email. She stated she will locate it and forward it to the Policy Committee members prior to the next Policy Committee Meeting on November 12, 2019.

This item was tabled.

## f. Require that SDPD officers provide and/or call for medical assistance in all situations where a person shows signs that they might be in medical distress (Committee Chair Brandon Hilpert)

2<sup>nd</sup> Vice Chair Taura Gentry reported that in the Committee's previous meeting minutes, it states that the Chief already addressed this concern. Lt. Bennett was going to provide the Committee with what the policy is now. The community member requested SDPD create a policy in a clear and concise language that once an officer call for medical assistance, the officer cannot cancel the call. The member believes that SDPD officers do not have the authority to cancel any call for medical attention. She wants to ensure that those types of calls cannot be rescinded by an SDPD Officer, or anyone, until it has been cleared by a medical professional. Captain Morris stated that a new policy came out in June 2019 that is different than what the community member is requesting. The Committee discussed times when the person does not want medical assistance and then the person is forced to pay for medical assistance. The Committee will formalize this recommendation and decide at its next meeting whether to refer this matter to the Board.
