### a. <u>Draft Fiscal Year 2015 Consolidated Annual Performance and Evaluation Report</u> (CAPER)- Staff Report

The CAPER is prepared on an annual basis for submittal to the United States Department of Housing and Urban Development (HUD), and it is required given the annual funding granted to the City as part of the following federal programs: Community Development Block Grant (CDBG); HOME Investment Partnerships Program (HOME); Emergency Solutions Grants (ESG); and Housing Opportunities for Persons with AIDS (HOPWA). The CAPER provides an assessment of the City's progress toward its goals and high priority needs for these federal programs. The CAPER reports on how funds were spent during the reporting period and the beneficiaries of the community development, social services, and housing activities undertaken.







#### \*Entrances




#### TROLLEY LINE

#### \*Trolley stop is "Civic Center", location on 2<sup>nd</sup> and C Street.


