Update/Add categories, definitions to Discipline Manual & Matrix

- i. Need to formalize that discipline memos need to state original discipline, as well as any final discipline after appeals
- ii. Recommendation that discipline memos must be completed within 14 days of serving discipline
- iii. Need to revise manual to clarify dates/timelines of when employees are notified of disciplinary action vs. when they are given the disciplinary letter
- iv. Need to clearly define "Minor Policy Violation"
- v. Need to add a new "Sustained Excessive Force (causing injury)" with a stronger discipline than "low level/Non-injury to suspect"

Suggestion: Excessive Force with injury should start at the 2nd offense for non-injury (suspension)

- D. Formal Review of SDPD's disciplinary tracking for sustained findings.
  - i. Motion for CPP to review SDPD's discipline tracking process to ensure officer discipline and make recommendations as appropriate.

- VI. New Business (Discussion/Action) Committee Chair Brandon Hilpert
  - 1. SDPD Procedure 1.43: Require officers involved in officer-involved shootings must undergo a psychological review before returning to field duty

It would be a good recommendation to add this to policy to have these assessments. It would be a good idea to consider any unexpected side-affect in having psychological assessments. Tabled.

- SDPD Procedure 1.55- De-escalation: Discuss usage of profane language as a "de-escalation" tactic. Chair Hilpert can reach out to other oversight groups in California to see if they have found about this. Robin will look at peer reviewed research and can come back with findings. Tabled.
- 3. SDPD Procedure 5.10: Officers Uniform Policy Complaint for Blue Lives Matter movement and wearing items that have the thin blue line. Possibly bring uniform policy up to date. Will wait until complaint comes to the Commission and if the team wants to recommend to Policy then we will move forward from there. Tabled.
