 - i. Need to formalize that discipline memos need to state original discipline, as well as any final discipline after appeals
 - ii. Recommendation that discipline memos must be completed within 14 days of serving discipline
 - iii. Need to revise manual to clarify dates/timelines of when employees are notified of disciplinary action vs. when they are given the disciplinary letter
 - iv. Need to clearly define "Minor Policy Violation"
 - v. Need to add a new "Sustained Excessive Force (causing injury)" with a stronger discipline than "low level/Non-injury to suspect" Suggestion: Excessive Force with injury should start at the 2nd offense for non-injury (suspension)

Chair Brandon Hilpert moved recommend to SDPD update the Discipline Manual and Matrix to: 1. Command shall complete discipline memo within 14 days after discipline has been issued. 2. Update Discipline Manual to indicate when officers must be notified and when discipline must be issued. 3. Add a description/definition of "Minor Policy Violation". 4. Add a new category of "Sustained Excessive Force (causing injury)" with a recommended first offense being suspension. Commissioner Andrea Dauber-Griffin seconded the motion. The motion passed with a vote of 4-0-0. (Time 54:51)
