Motion was made by Ken Martone to: upon notification of receipt of the Command Discipline Report by Internal Affairs, the team shall meet to review the report. If the team determines that more information is needed, the team leader shall request a meeting with the Commanding Officer who imposed the discipline or a member of the Department designated by the Chief of Police authorized to review the discipline imposed.

That in addition to the reading of the Command Discipline Report, the team will give a brief synopsis of the case and such other information as the team deems pertinent to the case. Any team member of CRB member may make a motion to disagree with the discipline imposed. The motion to disagree must include a statement as to why the maker of the motion is in disagreement.

Upon a majority vote of the CRB to disagree with the discipline imposed, the Chair of the CRB shall there by be authorized to inform the Mayor of the action of the Board.

That the drafting of the Standing Rules to implement the CRB discipline review procedure as approved, be referred to the Rules Committee. 2nd by Joe Craver

Deputy City Attorney Mike Giorgino: commented that a clarification of the 2 types of Standing Rules was needed. There is an Operational Standing Rule and the other is the Administrative Standing Rule. The Operational Standing Rule requires City Attorney and Mayoral approval. The Administrative Standing Rule requires approval from the Board.

Ken Martone Added to the Motion: "with the understanding that the Deputy City Attorney would be available to Assist and Review."

Executive Assistant Chief Ramirez: requested that the City Attorney research the Police Officers Bill of Rights in regards to any violations in the motion.
