- I. **CALL TO ORDER/WELCOME**: Chair Doug Case called the meeting to order at 6:05 p.m.
- II. **PURPOSE OF THE COMMUNITY REVIEW BOARD ON POLICE PRACTICES**: Chair Doug Case explained the purpose of the Community Review Board on Police Practices to those in attendance.

- III. APPROVAL OF MINUTES: Motion made by 1<sup>st</sup> Vice Chair Joe Craver to approve the minutes of April 25, 2017. Vote: 15-yes/0-no/0-abstentions. Motion passes unanimously.

 A. Board Member Godwin Higa-5 1/2 years of service on the CRB: Godwin Higa was not present - Tabled.

## VI. PRESENTATION: Speakers: Captain Brian Ahearn/ Lt. Marshall White/ Sgt. Allan Brouchard - San Diego Police Department Gang Suppression Team (GST)

Lt. Marshall White described his role in the GST. He handles investigations and is currently overseeing a review of the SDPD database. There are 3,757 documented adult gang members. This number is down from 4,042 last year. There are currently 25 city-wide documented gang youth. This number is down from 47 last year.

Sgt. Allan Brouchard gave a presentation on the high profile saturation of the GST in high crime areas.

The CRB invited tonight's speakers to return to its next Open Session Meeting with statistics on ethnic demographics.

A. Operational Standing Rule on Case Review- Legal Questions Arising during Case Review

Motion made by Pieter O'Leary to strike the following language: "apply their own interpretations of the law, formulate legal conclusions." Vote: 15-yes/0-no/0-abstentions. Motion passes unanimously.

Motion made by Tom Lincoln to change the last sentence of the 3<sup>rd</sup> paragraph to: "an officer cannot be held to a standard that differs from the directions of SDPD at the time of the incident" instead of "An officer cannot be held to a standard that is not being followed by SDPD at the time of the complaint." Vote: 14-yes/1-no Taura Gentry/0-abstentions. The motion passed.

B. Administrative Standing Rule on Format for Case Reports Motion made by 2<sup>nd</sup> Vice Chair Brandon Hilpert to add two (2) columns to the "CHANGES MADE DURING CASE REVIEW" chart and removing the prohibition of zip codes. Vote: 14-yes/0-no/0-abstentions. The motion passed unanimously.

C. Administrative Standing Rule on Continuing Educational Requirements The Board discussed the benefit of participating in a ride-along.

Motion made by 2<sup>nd</sup> Vice Chair Brandon Hilpert to require ride-along twice a year. Vote: 14-yes/0-no/ 1 abstention. The motion passed.

D. Audit Procedure for Category 2 Complaints

Motion made by 2<sup>nd</sup> Vice Chair Brandon Hilpert to accept the CAT II Review/Audit Options as presented. The Board will review the options every quarter and begin to use it with the start of the new fiscal year. Vote: 14-yes/1-no Maria Nieto-Senour/0-abstentions. The motion passed.
