Subject: Supplemental Cultural Resources Assessment for the Campus Point Master Plan Project, City of San Diego, San Diego County, California

Rincon Consultants, Inc. (Rincon) was retained by LPA Design Studios, on behalf of Alexandria Real Estate Equities, to conduct a supplemental cultural resources assessment for the Campus Point Master Plan Project (project) in the City of San Diego, San Diego County, California. A Supplemental Environmental Impact Report (SEIR) was certified for the project on April 5, 2017 by the City of San Diego (Project No. 336364; SCH No. 2014091073; SEIR to EIR No. 91-0360 [SCH No. 92121002]). The approximately 58-acre project site has since been expanded to the south to include an additional 36 acres of land not previously analyzed as part of the SEIR. As a result of these project changes, a supplemental cultural resources record search and field survey were performed by Rincon. The purpose of this memorandum is to document the findings of the supplemental cultural resources assessment. This study was completed in accordance with the requirements of the California Environmental Quality Act (CEQA).

Project Location

The project site is located within the University Community Planning area of San Diego and is situated within a commercial complex northeast of the Interstate 5 and Genesee Avenue intersection within the San Diego city limits (Figure 1). The original project site encompassed 58.19 acres of land on Assessor's Parcel Numbers (APNs) 343-230-13 and 343-230-14. The newly expanded portions of the project site include approximately 36.60 acres of land in APNs 342-230-40, 343-230-13, 343-230-14, 343-230-42, 343-230-17, 343-230-41, 343-230-43 and 343-230-38 and is depicted on Township 15S, Range 03W, Sections 6 and 7 of the United States Geological Survey *Del Mar*, CA 7.5-minute quadrangle (Figure 2). Commercial buildings and associated parking lots are located to the north and south of the project site, with Interstate 5 to the west and vacant land to the east.

Project Description

The project consists of a neighborhood development permit (NDP) entitlement application (Process 2) for the existing Campus Point campus buildings (10260, 10290, and 10300 Campus Point Drive and the associated central plant facilities. The owner of the Campus Point campus has purchased the adjacent Genesis campus which contains six existing buildings (4110, 4161, 4210/4224, 4242, and 4244 Campus

Point Court and 10210 Campus Point Drive). The combined area of the Campus Point and Genesis campuses comprises the project area.

The Campus Point Master Plan project would retain two of the existing buildings and the associated central plant facilities (10290 and 10300 Campus Point Drive) in the Campus Point campus, referred to as CP1, CP2, CP1-1, and CP2-1, and four existing buildings on the Genesis campus (4210/4224, 4242, and 4244 Campus Point Court and 10210 Campus Point Drive), referred to as CPS1 through CPS4; but, includes plans to demolish the 10260 Campus Point Drive and 4110 and 4161 Campus Point Court buildings. The project would increase intensity by constructing four new buildings (CP3, CP5, CP6, and CP7), and a parking structure (P2). Other site improvements include grading, site utilities, access improvements, drainage improvements, landscaping, irrigation, and hardscape.

The proposed development would occur within previously disturbed and developed portions of the site and there would be no encroachment into, or impacts on, any steep slopes or other environmentally sensitive lands located on the site.

Environmental Setting

The project site is located a hillslope and is situated at an elevation of approximately 295 feet (90 meters) above mean sea level. The nearest water source is Peñasquitos Creek, located approximately 1.0 mile to the north/northeast. The soils in this area include an Altamont clay-Chesterton fine sandy loam complex that consists of deep, well to moderately well-drained soils formed in material weather from fine-grained shale and sandstone and can be found on uplifted marine sediments and old terraces (California Soil Resource Lab 2019). Vegetation within the project site consists of ornamentals, seasonal grasses, mature trees, and coastal scrub.

Existing Project Site Conditions

The project site is largely developed with six existing buildings surrounded by parking lots and landscaped areas. A geotechnical report prepared for the project states that much of the site was mass graded in 1979 and 1980 as part of the initial development of the property (Geocon Incorporated 2019:4). The geotechnical boring study determined that previously placed fill covers much of the project site with depths ranging from 20 to 110 feet. The fill, which was likely placed over the project site during the mass grading activities overlies the Scripps Formation and Ardath Shale (Geocon Incorporated 2019:5).

Cultural Resources Record Search

On August 28, 2019, Rincon conducted a record search of the California Historical Resources Information System at the South Coastal Information Center (SCIC) located at San Diego State University. Because the record search performed for the 2017 SEIR study was completed in 2013, Rincon's SCIC search incorporated both the original and newly expanded portions of the project site, and a 0.25-mile radius surrounding it. The SCIC search also included a review of the National Register of Historic Places (NRHP), the California Register of Historical Resources (CRHR), and the California Historical Landmarks list. Results from the records search can be found in Appendix B of this memorandum.

The SCIC record search identified 86 previously conducted cultural resources studies within a 0.25-mile radius of the project site. Of these, 17 cultural resources studies include portions of the project site.

Table 1 lists the previous studies within the record search radius. Results of the two studies (SD-15908 and SD-15914) conducted for the Campus Point Project are briefly discussed below.

Carmen Zepeda-Herman prepared SD-15908, Draft Results of Historical Resources Survey of Campus Point Project, in 2013. Carmen Zepeda-Herman and Harry Price prepared SD-15914, Draft Environmental Impact Report for the Campus Point Project, San Diego, California Project No. 336364, SCH No. 2014091073, in 2015. These two studies included a record search and pedestrian field survey of the original project area. One previously recorded prehistoric resource (P-37-005613/CA-SDI-5613) was located during the record search and field survey. Archaeological investigations at CA-SDI-5613 in 1979 and 1999 identified two burials and associated Archaic Period artifacts (Zepeda-Herman 2013:13). The 2013 survey identified five flakes and one scraper; these artifacts were located outside of the project's Area of Potential Effect (APE) but within the SCIC's mapped boundary of CA-SDI-5613. Zepeda-Herman (2013:23) concluded that because of past construction, CA-SDI-5613 no longer retains sufficient integrity to be considered eligible for listing on the CRHR. The 2015 survey identified no historical or archaeological resources as the majority of the survey area was covered with asphalt parking lots and existing buildings (Zepeda-Herman and Price 2015: 4.4-4)

The SCIC record search identified four previously recorded cultural resources within a 0.25-mile radius of the project site (Table 2). These include one historic period built-environment resource and three prehistoric archaeological sites. One prehistoric site (P-37-005613/CA-SDI-005613) is located adjacent to the project site, approximately 630 feet (0.12 mile) to the north/northeast. A brief description of the resource is provided below.

P-37-005613/CA-SDI-5613

P-37-005613/CA-SDI-5613 was first recorded by Charles Bull and David Hanna in 1978 and consists of midden soil, *Chione* and *Aequipecten* shell, debitage, one scraper, and one chopper. The site has two artifact concentrations (Loci A and B), and when taken together the site measures approximately 305 meters by 122 meters. Locus B appears considerably smaller than Locus A, but is noted by Bull and Hanna as having a greater artifact density. Lithic material within the site includes felsite, porphyritic felsite, andesite, basalt and quartzite. At the time of recordation, Bull and Hanna (1978) noted disturbances within CA-SDI-5613 that include grazing, plowing, and grading of three roads. Grading disturbances were minimal, as relatively low shallow cuts were observed. This site was determined ineligible for listing on the CRHR.

Review of Historical Topographic Maps and Aerial Imagery

Rincon also reviewed available historical topographic maps and aerial imagery of the project site to determine past land use (NETRonline 2019; USGS 2019a-g). Historical aerial photographs indicate that the entire project site was graded by 1980 with Campus Point Drive constructed by 1981. Three buildings are present on the property by 1990. Aerials from 1990 through 1996 indicate that during this time, the majority of the project site has been developed upon, with the exclusion of a small northwest to southeast trending strip of land at the northern portion of the project site. By 2002 the area has been fully developed (NETRonline 2019).

Field Survey Methods

On August 28, 2019, Rincon conducted an archaeological pedestrian field survey of the newly expanded portion of the project site. The 2017 SEIR study area was not examined as part of this field work effort as it had been surveyed less than five years ago. Transect intervals for the survey were spaced no more than 10 meters apart. All exposed ground surfaces were examined for artifacts (e.g., flaked stone tools, tool-making debris, stone milling tools, ceramics, fire-affected rock), ecofacts (marine shell and bone), soil discoloration that might indicate the presence of a cultural midden, soil depressions, and features indicative of the former presence of structures or buildings (e.g., standing exterior walls, postholes, foundations) or historic debris (e.g., metal, glass, ceramics). Ground disturbances such as burrows and drainages were also visually inspected. Survey accuracy was maintained using a handheld Global Positioning Satellite unit and a georeferenced map of the project site. Site characteristics and survey conditions were documented using field records and a digital camera. Copies of the survey notes and digital photographs are maintained at the Rincon Carlsbad office.

Field Survey Results

As previously mentioned, the project site is located within a paved urban setting with pockets of ground exposure (Photograph 1, Photograph 2). Due to the developed nature of the survey area, ground visibility was poor (approximately 10 percent). Soil within the project site consisted of an Altamont clay-Chesterton fine sandy loam complex populated by ornamentals, seasonal grasses, mature deciduous and coniferous trees, and coastal scrub (Photograph 3). Disturbances within the project site were abundant and included extensive commercial development, as well as grading and paving for parking lots, sidewalks, roadways, and landscaping (Photographs 4-6). No archaeological resources were identified during the field survey. All standing buildings and structures were less than 45 years of age

and as such, did not meet the Office of Historic Preservations guidelines to be considered historic-era resources.

Findings and Recommendations

The results of the supplemental cultural resource assessment found no evidence of cultural resources within the expanded portion of the project site. A cultural resources records search performed for the entire project area identified one previously recorded archaeological resource (P-37-005613/CA-SDI-5613) located within the 2017 SEIR study area. This archaeological resource was determined ineligible for listing on the CRHR (City of San Diego 2017). As a resource ineligible for the CRHR, site P-37-005613/CA-SDI-5613 requires no further management consideration.

The field survey of the expanded portion of the project was negative for archaeological resources. Review of historical aerial photographs and topographic maps identified no previously recorded built environment resources on the project site. All existing buildings located within the project site are less than 45 years old and are not considered historical resources under CEQA.

Geotechnical data indicate that the project site was mass graded in 1979 with 20 to 110 feet of redeposited fill subsequently placed over the property (Geocon Incorporated 2019). Given the extent of these past ground-disturbing activities, any archaeological remains that may have once been present on the property are likely no longer extant. These findings indicate that even if project-related activities extend below the redeposited fill level, there is a low potential to impact archaeological resources. Rincon recommends a finding of **no impact on historical resources**. The project is required to adhere to regulations regarding the unanticipated discovery of archaeological resources and human remains, detailed below.

Unanticipated Discovery of Archaeological Resources

If cultural resources are encountered during ground-disturbing activities, work in the immediate area must halt, and an archaeologist meeting the Secretary of the Interior's Professional Qualifications Standards for archaeology (National Park Service 1983) should be contacted immediately to evaluate the find. If the discovery proves to be significant under CEQA, additional work such as data recovery excavation, Native American consultation, and archaeological monitoring may be warranted to mitigate any significant impacts.

Human Remains

The discovery of human remains is always a possibility during ground disturbing activities. If human remains are found during the excavation, the State of California Health and Safety Code Section 7050.5 states that no further disturbance shall occur until the County Coroner has made a determination of origin and disposition pursuant to Public Resources Code Section 5097.98. In the event of an unanticipated discovery of human remains, the County Coroner must be notified immediately. If the human remains are determined to be prehistoric, the Coroner will notify the Native American Heritage Commission, which will determine and notify a most likely descendant (MLD). The MLD has 48 hours from being granted site access to make recommendations for the disposition of the remains. If the MLD does not make recommendations within 48 hours, the land owner shall reinter the remains in an area of the property secure from subsequent disturbance.

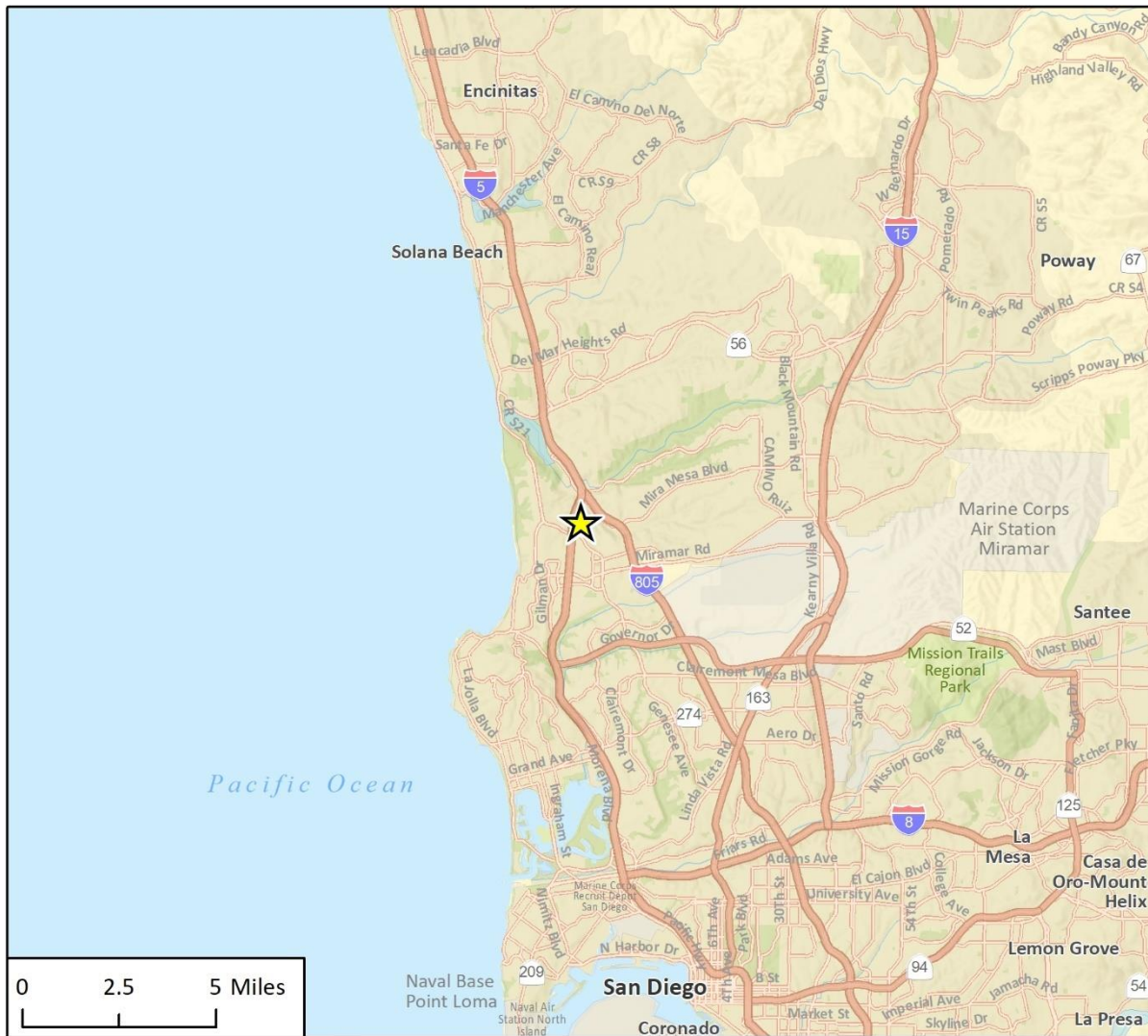

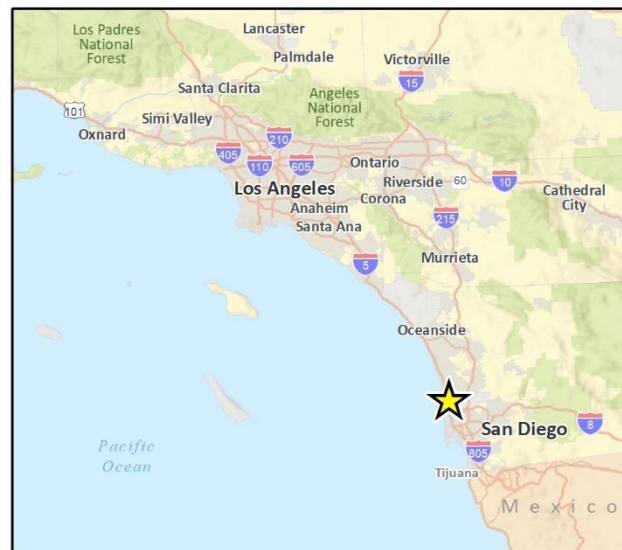
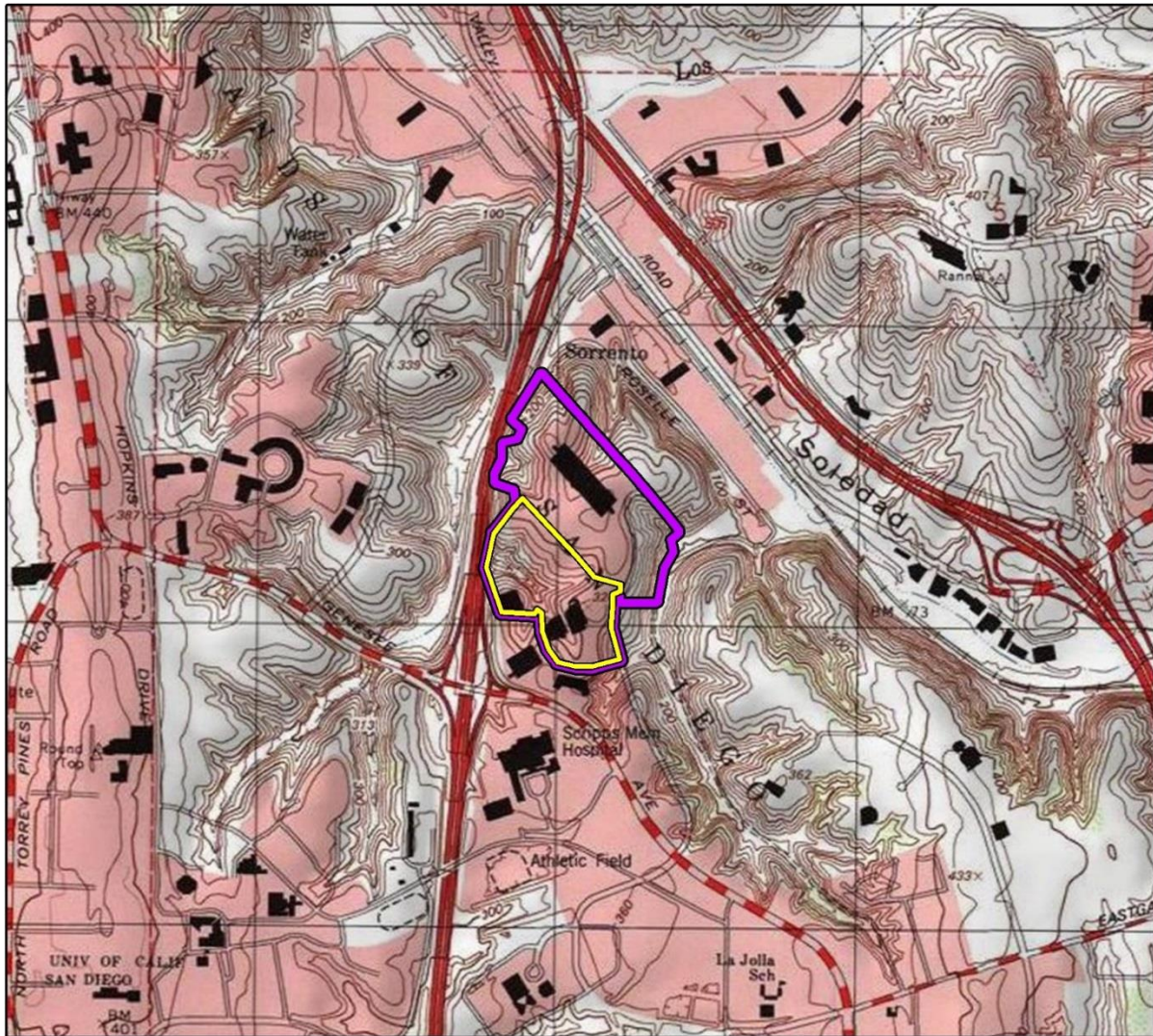


Fig 1 Regional Location

Figure 2 Project Location Map



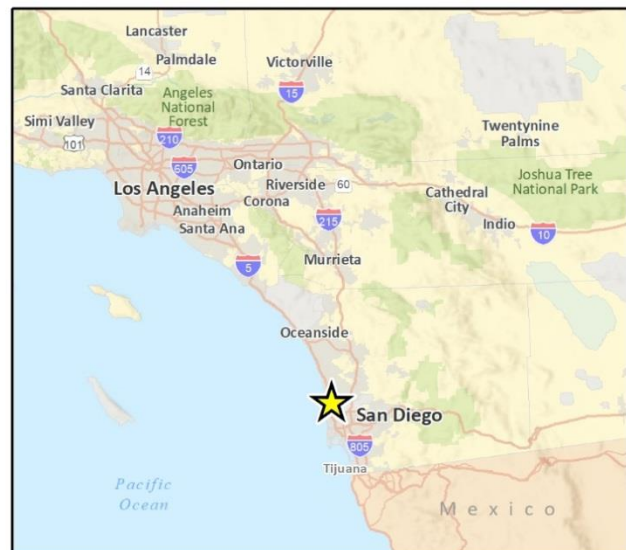
