Land Use & Housing Committee

Safe, stable homes are critical to the constituents we serve, the sustained growth of our economy, and the opportunities for future generation. In the past two years, our City Council has taken critical steps to make progress on the dual crises of



homelessness and insufficient affordable and workforce housing. However, we are not keeping up with population demands and the persistent failure to meet this need has jeopardized both individual dreams and our City's future.

I intend to work to ensure that policies are drawing on known best practices and innovative solutions so we are able to finally implement a deliberate and holistic plan to house our homeless, ensure development of affordable housing is proportional to our overall housing stock, and further prioritize much-needed units, like Permanent Supportive Housing.

Council At Your Door

For the last two years I've made it a priority for my office to be accessible as possible. As residents, you are entitled to know what your elected officials are doing, why it's important, and its impact on your neighborhood. I also want to hear directly from you, what your concerns are and how I can better advocate for the city services you depend on.
