NEWS FROM COUNCILMEMBER CHRIS WARD

The San Diego City Council recently convened a special meeting to address homelessness, devoting an entire day to reports and updates from the Mayor, County, Housing Commission, experts from San Diego State, service providers, and members of the public. It was the first time that a meeting has been specifically committed only to addressing our homeless crisis, and it was exceptionally necessary as we continue working to produce solutions for thousands of unsheltered San Diegans.

District Three has been at the forefront of this ongoing crisis - both Downtown and increasingly in all of our communities as the challenge has grown. At that meeting, we heard a number of encouraging updates from those who are working hard on the frontlines to help the thousands of San Diegans struggling with homelessness and to accelerate our ability to build lasting regional solutions that provide the support and opportunities these people need to get back on their feet.

Budget Season

April marks the beginning of budget season, with the Mayor's initial proposed budget being formally presented to City Council on Monday, April 17.

There will be a series of hearings during the following six weeks where Councilmembers, city staff, and members of the public can provide feedback and recommendations for our spending priorities in the coming fiscal year.

In addition to regularly scheduled Council meetings, there will be a special evening session on Monday, May 15th for those whose schedules do not allow them to participate during the workday.

As we face challenging new expenses and seek to balance the neighborhood ser-
