Meanwhile, as Vice-Chair of the Regional Task Force on the Homeless, I was extremely excited to announce the hiring of Gordon Walker as the organization's new CEO. Mr. Walker arrives with an exceptional record as Utah's former state director of housing and community development, where he led a national conversation about Housing First strategies and where the chronically homeless count was reduced by 91% over a ten-year period. His track record demonstrates exactly the type of leadership we need for the San Diego region, and I'm very excited to have him on board.

We continue to track critical opportunities at the state level that can also make a big difference locally. Assemblymember Todd Gloria secured \$10 million in the new state budget to help homeless youth, the City Attorney's SMART program

Final Budget Update

The City's budget for the next year was finalized in June, with several major changes late in the process. Up against a an initial proposal from the Mayor to cut a third of the city's arts and culture funding, the city council successfully restored the funding, and in recent weeks nearly \$12 million in grants for the upcoming year was announced, spread across 133 local arts nonprofits.

The City Council added \$3 million to the initial budget in public safety funding to ensure minimum police staffing in all communities throughout the year. The budget also includes increased funding for recruitment and retention to better address our staffing shortfall, and funding for a nationwide search for our next police chief, who will replace the retiring Chief Zimmerman.

Finally, the City Council also voted against scheduling the Mayor's proposed special election to consider a convention center expansion. While expanding the convention center remains a major priority, the \$5 million or more the election would cost, and a variety of concerns about the specifics of the proposal made the general election in 2018 a better time to present voters with the best possible plan. The \$5 million set aside by the Mayor in the final budget to pay for the special election will remain unused until we're able to re-consider other possible uses for that money later in the fiscal year.
