Dear Neighbors:

July ended on a high note, as the City Council unanimously approved the Equal Pay Ordinance that I first proposed in February. With this approval, San Diego becomes the largest city in the nation to adopt equal pay rules, and we will continue to be a leader for economic justice and fairness.

Recent data found that the gender pay gap is much worse in San Diego than in California overall. Compared to white men, the study found women making 72 cents, black women making 50 cents, and Latinas making just 37 cents. Not only is this a problem of fairness, it makes it more difficult for women to achieve financial independence, provide for their families or prepare for a secure retirement.

NEWS FROM COUNCILMEMBER CHRIS WARD

For San Diego to fulfill its responsibility as a place where anyone has a fair chance to work hard and succeed, we have to use our legal and economic power to ensure that nobody is at a disadvantage because of their gender or ethnicity. This ordinance requires contractors doing business with the city to certify that they provide equal pay regardless of gender or ethnicity, and empowers the city to examine their records if necessary to verify fair pay. It establishes the framework that allows us to partner with businesses receiving tax dollars to make sure this a fair place to work.

It's an important step forward for the city, continuing the standard established by our Living Wage and Equal Benefits policies, and building on the demonstrated commitment to fair

Council Action on Housing

On July 24, the City Council held a special meeting entirely devoted to our Housing crisis and approaches to make housing more affordable for San Diegans.

Council voted to reduce the fees for building companion units or 'granny flats,' adjusted parking requirements to allow more to be built, and added guidelines to ensure that these new units go directly to easing the housing shortage for San Diegans who need relief the most.

Council also voted to expedite the approval process for projects focused on affordable, in-fill development, and sustainable building projects that help the city reach its environmental goals for development.

The following week, City Council approved the funding for 627 affordable units across six projects throughout the city, including 79 affordable units in Bankers Hill through the New Palace Hotel project.

Addressing San Diego's housing needs will be a long process, but the progress on policy and approval of funding for hundreds of new affordable units are important steps that will help hundreds of local families meet the cost of living and embrace the opportunities to thrive in our community.

Upcoming Issues: Share your thoughts

The City Council is on recess for most of August, but when it reconvenes in September, several major issues are expected to be considered. We want to hear your thoughts as we examine the policy proposals that are coming up and work towards the best solutions for District Three and San Diego.

Following a series of City Council hearings, proposed regulations for short term vacation rentals in the city are expected to be presented in September. Our office will be carefully reviewing the proposals and seeking opportunities to keep our neighborhoods safe and welcoming while respecting property rights and ensuring that visitors are able to enjoy what makes our unique communities special.

City Council is also expected to continue work on the regulatory framework for marijuana sales. Councilmember Ward continues to work closely on this issue to ensure an equitable and workable balance of public safety and personal right to access is implemented throughout the city.
