- ITEM 3A: Estimated time 30 minutes Listings: Balboa Park NHL Address: 1439 El Prado Historic Name: House of Charm Significance: National Historic Landmark District Mills Act Status: N/A PTS #: N/A **Project Contact: Luce Studios** Treatment: Rehabilitation Project Scope: This rehabilitation project includes replacing the entry at the Alcazar garden to match the 1915 door, while also replacing the main entry glass doors which are quite heavy and difficult for visitors to open; creating large sliding stucco doors at two existing archways along the east arcade which would be open during the day but closed at night; creating a new black box theater space one level below grade in place of the loading dock with a new sculpture court at grade level; and retrofitting the existing roof terrace structure to include a minimal glass handle rail set back from the current parapet

to allow these spaces to be occupied by the public. Existing doors from the museum to the terraces would be upgraded to match the 1915 doors which were much more ornate. The 1915 building was completely skylit throughout. The proposal also includes the addition of two skylights in the upper level peaked roof area. <u>Existing Square Feet</u>: <u>Additional Square Feet</u>: approx. 2,000 <u>Total Proposed Square Feet</u>: Prior DAS Review:

<u>Staff Presentation</u>: Overall, staff felt that the proposed work was consistent with the Standards. Staff did have some concerns with the skylights at the entry.

Applicant Presentation: Building was reconstructed in 1996, with adaptations made at that time. Four main components of project: the building entries, infill of the loading dock with new terrace above, public access and use of the terraces, and the skylights. The main concept of the project is to open the ground floor to the public, with paid access museum space on the second floor. Doors off of Alcazar garden will be restored to solid wood doors that can be opened with new glass storefront/doors behind. The arcade entry will be modified to create sliding stucco panels within the arched recesses on the façade, allowing the new openings to be completely concealed when closed. The non-historic skylight within the arcade may be closed and historic lighting reintroduced. The existing entry glass doors, which are minimally operable, will be replaced with a new glass storefront. The loading dock, which is not original and was introduced in 1996, is inaccessible and unusable. The proposal is to infill that loading dock with usable space and a new deck above, which would be level with the arcade. The windows that were added in 1996 will be cut down to provide access to the new interior space and terrace above. The existing terraces on the east facade were publically accessible historically, and will be recaptured. The access doors will be restored to their historic appearance based upon the original historic plans. The roofing will need to be addressed with a raised pedestal system. A new recessed rail, possibly glass, will be added for safety, but will not be visible from the plaza. They would like to add skylights on the gable of the entry to provide more light to the space within.

	Hospitality. On the Alcazar Garden side, she is pretty
	certain that the original wood doors opened out. Likes
	the idea of a recessed glass entry, but would like to see
	more detail. The arcade approach is interesting, and is
	going into new territory. The fact that the panels close at
	night is good. Less inclined to put a skylight in the
	existing tile roof, because it is such a historic element.
	Allowing the restored glass doors to provide the light to
	the space would be preferable. As to the new rail at the
	terrace, a cable rail system may be preferable to a glass
	rail, which gets dirty and can be reflective. Should return
	to DAS once more detail is worked out.
