A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND THE DEPUTY CITY ATTORNEYS ASSOCIATION OF SAN DIEGO REGARDING TERMS AND CONDITIONS OF EMPLOYMENT FOR FISCAL YEAR 2021.

WHEREAS, by San Diego Resolution R-312536, the San Diego City Council (Council) approved a Memorandum of Understanding between the City of San Diego (City) and the Deputy City Attorneys Association of San Diego (DCAA) regarding terms and conditions of employment for employees represented by DCAA for Fiscal Year 2020; and

WHEREAS, Article 4 of the Memorandum of Understanding provides a reopener to negotiate proposals for a successor Memorandum of Understanding (MOU) for Fiscal Year 2021; and

WHEREAS, the City's Management Team and representatives of DCAA met and conferred pursuant to the reopener provision and reached a tentative agreement on terms and conditions of employment for a one-year MOU, and DCAA members ratified the agreement; and

WHEREAS, under the Meyers-Milias-Brown Act (MMBA), the state law related to collective bargaining between the City and its represented employees, and Council Policy 300-06, it is within the discretion of the Council to approve the MOU; NOW, THEREFORE,

BE IT RESOLVED, pursuant to the authority of the MMBA and Council Policy 300-06, the Council of the City of San Diego approves the MOU between the City and DCAA for Fiscal Year 2021, on file in the Office of the City Clerk as Document No. ^{KR-}313136.


