Total habitable will be 2985 sa ft. > Committee Approved 4-0 > MOTION to approve: BD/BZ All in Favor 12-0-0 Chair not voting > 8d: #622028 5076 Bayard & 919 Tourmaline St > Presenter: Robert Bateman > Creation of two lots using the small lot subdivision process category 3 in the RS1-7 zone. > This Item was trailed until the next Agenda since no one was in attendance to present > 7:15pm Two people remaining in attendance > Bill Zent departed at 7:23pm > Item 9: Streets & Sidewalks Committee - Eve Anderson > We did a roundtable on the scooters and discussed if new regulations are working but we think most of the slow down is due to the time of year and we won't know really until spring break. > We also had 5 people attending from Foothill Blvd to discuss traffic issues. > MOTION CC/EG: Request that SD Transportation Engineering re-examine Foothill Blvd specifically at Vickie Dr to confirm need for immediate traffic calming and safety measures for the unacceptably dangerous area. > Discussion: Three or four years ago there was past discussion and a proposal with the City to put in 4 traffic circles and they approved the one at Loring but we never got a clear answer about the other 3. Let's try and find out what happened to the other three. Karl researched the CIP status online but it's likely to take years more and the roundabout that has been approved at Loring will only be in 2021. Shouldn't we try for something else shorter term? > ITEM 10: Mission Blvd Public Spaces & Active Transportation Plan Action Item - Ed Gallagher

> Related to the Mission Blvd redesign project and the Subcommittee met and discussed:

> Pocket parks, Mission Blvd, and Boardwalk. EG presented list of specifics to be put into a PBPG letter in each area. In 2012 the PG produced a report for this area.

> The consensus was that the report that came out - though it included many thing we liked, it fell short on some things and our goal was to come up with specific recommendations for any process moving forward. The final plan did not

include the Boardwalk but we think it needs to be included.

> Pocket Parks - too much emphasis in plan to retain parking spaces but all the feeder streets that abut the boardwalk between Mission Blvd and Ocean Front Walk from PB Drive to Diamond St offer ideal locations for pocket parks and parks should replace parking.

> NOTE EG made changes to to each section that will be incorporated into a letter

- > MOTION to approve Pocket Parks section. 12-0-0 All in Favor Chair not voting
- > Mission Boulevard Safety Improvements
- > NOTE: ED presented specific wording to be in the letter and below is a short summary;
- > Strongly recommends roundabouts at every intersection along Mission Blvd from PB Drive to Diamond and include rideshare/drop-off/pick-up locations and also a Mobility Hub. Eventual redesign must include must wider sidewalks on both east and west sides of Mission.
- > MOTION CC/JL to Approve creation of letter based on written submission from the SubCommittee and discussion at the meeting
- > Proposed amendment by JB there are bike lanes on Mission Blvd that are not connected to PB Pathways should be accepted by CC and JL
- > Proposed amendment by MB/CC: Roundabouts should only replace signals
- > Accepted by CC and JL All in Favor, Chair not voting
- > Boardwalk/ Ocean Blvd
- > Widen the Boardwalk from Grand to PB Drive and eliminate vehicular access on Ocean Blvd from Thomas to Grand (leaving emergency access as OK).

- > Recapture PROW from any encroachments into public space
- > Restore and complete the seawall
