There are City staff and two tree services contractors who can provide crews locally and from other California locations. Media messages will still be developed, to reinforce the value of trees and the changes that can be made to reduce future storm damage and increase tree health.
- b) Jeremy Barrick described the difficulty in getting specific budget information for FY 2016 expenditures, as urban forestry activities are not tracked specifically in most departments. The staff is beginning to develop FY 2017 budget requests.
