Monthly SDPD Issues Report - Officer John Briggs, Community Relations Officer
Officer Briggs reported on a non fatal officer shooting today in the Cholas Creek area. Five arrests have been made on the recent home burglary cases and the task force is making good progress. School is out soon with forecasts for aimless teenagers roaming the streets and the CVS pharmacy. Christian Tresize asked if the five suspects are related to the Chilean Crime ring. Officer Briggs was not able to make a statement on the ongoing investigation.

Public Forum - Non-Agenda Items (Three minutes per speaker, twelve minutes per topic) Chairman Metcalf asked if there were any, Ali Dressel introduced herself representing Climate Action, a local not for profit group, with the goal of achieving zero carbon and dealing with future climate change, and evaluating community priorities in order to make sure that the city is working to include community feedback. Chairman Metcalf asked the collective group of representatives, Emily, Emily, Cole and Mark to agree to work to allow volunteer groups such as DMM be allowed to continue to meet virtually. He expressed the need to relieve the burden placed on both the volunteers as well as the neighborhood attendance. #### **Action Items:**

Reconsideration of the March approval of the Toll projects SCR for conformance with the Terrazzo Bougainvillea/Sunrise Hill Design Guidelines Related to the Projects walls and landscaping

Chairman Metcalf turned this item over to Vice Chairman Tim Guy for discussion. Tim Guy introduced the matter of the recent concerns raised by members of the community regarding the lack of compliance with the community plan design guild lines related to the walls. Toll representatives Jason and Spencer provided handouts and commented that the constructed walls will be demolished and replaced with abbreviated walls and wrought iron fencing that is in compliance, and noted that all new plan designs as revised will be in compliance. Diane Korsh asked about feedback from Lisa Ross and Chairman Metcalf reported that she was satisfied. Chairman Metcalf commented on the process required going forward for the landscaping design guidelines and requirements of the new home owner for plan compliance and timeline of submission. Tim Guy made the motion to reinstate the approval of the Toll plan as revised, Wendy Poyhonen seconded and the motion was approved by a vote of eight in favor of, and one recusal.

Wendy Poyhonen commented on the cut through trail at the Alta Del Mar which is overgrown, and will contact Jeff Tibaldi to seek assistance from the Alta Del Mar HOA.
