The State of District Three

I can say without hesitation that I love my job. In the short 26 months I have been in office, I have worked with my colleagues to advance the goals you set for me of improving public safety, increasing infrastructure funding and strengthening our neighborhoods.

I am proud to share some of the accomplishments of the past year on these pages and at my State of the District presentation at the Birch North Park Theatre on February 23.

To be sure, the past year was busy and marked with success and tough challenges.

The City's budget forecast is not as

bright as it would have been had Proposition D been approved in November, and my Council colleagues and I remain focused on additional reforms and strategic decisions to stabilize our City.

Instead of seeing our finances as absolute deterrents to progress, I have seen them only as hurdles. And together, we have found creative ways to strengthen our communities in spite of a lack of extra funds.

The North Park Police Bike Team was made possible in part because of the generosity of Martin Calderon and the San Diego Police Foundation. The Azalea Park Water Conservation Garden was the culmination of a multitude of

partners. Urban Corps repaired Hollywood Park's stairs and switchbacks.

While it was an honor to be selected for the People in Preservation Public Policy Award from Save Our Heritage Organisation and with the Hero of Assisted Housing recognition by the National Association of Housing and Redevelopment, I was perhaps more proud to have completed curb and gutter work on Hawley Blvd. in Normal Heights, so neighbors homes no longer flood there during each storm.

My daily objectives are to help people and make San Diego a better place. I am grateful that so many of District Three's neighbors, business people and friends have contributed to these successes.

And more are on the way. Whether you care most about core public safety services, smooth roads, new parks, or fiscal strength, you should see positive progress in 2011.

I appreciate the opportunity to serve.

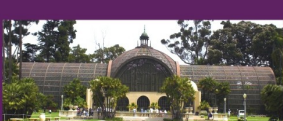

Infrastructure Improvements

Street Repairs



- The alley between 33rd and Wabash and University Ave. and Lincoln was repaved.
- A gravel alley in Kensington was re-grated following winter rainstorms.
- The alley behind 4267 Winona Ave. was grated.
- A metal plate was secured on the north side of the Upas St. and Fifth Ave. intersection.
- A patch of asphalt on Pamo Ave. was repaired.
- The deteriorated sections of an alley behind the 3900 block of Oregon St. were patched.
- A portion of the alley between 49th St. and Estrella Dr. was repaved.
- Asphalt patches were added to the alley behind the 3900 block of Arizona St.
- The decomposed granite on 38th St. next to Park de la Cruz was grated as a temporary solution to the poor street conditions. The street will eventually be repaved when funds allow.
- Alleys off N. Mountain View and behind 35th St. were repaired by City crews.
- Upas St. between 33rd St. and Bancroft St. will be resurfaced by the end of summer 2011.
- Herman Ave. from Thorn St. to Upas St. will be slurry sealed by the end of summer 2011.
- The 2900 and 3000 blocks of Madison Ave. were determined to be worthy of resurfacing and were added to the City's backlog list and will be improved when funds are available.
- Asphalt patching was completed in the 4600 block of 30th St. Permanent concrete repairs are the responsibility of the abutting property owner.
- Incomplete street repaving work on Lincoln Ave. was finished after follow up from the District Three office.

- Leftover construction asphalt was removed from Alder Dr.
- Two new concrete cross gutters were installed in North Park, one on the east side of 30th St. at North Park Way and one on the north side of University Ave. at Iowa St. Both were installed as a result from requests from the Council District Three office because the previous degraded cross gutters caused massive water ponding that inhibited pedestrian traffic.

Water Work

- A water leak was repaired in the 2400 block of Haller St.
- A leaking water main in the 4500 block of Copeland Ave. was fixed.
- A burst water pipe was repaired on the corner of University Ave. and Herman Ave.
- A serious water leak on Washington St. at Lincoln Ave. reported to the District Three office later led to a full excavation and fix of a larger infrastructure issue.
- Multiple sprinkler heads were replaced at the Azalea Recreation Center to curb water use.
- A waterline was hooked up on Canterbury Dr. in Kensington thanks to the District Three office, ending delays experienced by the homeowner.
- An investigation following water and sewer improvement work in the 3900 block of Wabash Ave. resulted in a determination that water pressure was in the expected range.
- Broken water lines near Marlborough Dr. and Middlesex were repaired.
- A water leak at Bedford Dr. and Edgeware Rd. was fixed.
- Standing water collected after rains on Hilldale Rd. because construction blocked access to storm drains was pumped.
- Water leaking onto the sidewalk and street near 35th St. and Meade Ave. was stopped.

Street Signs

- Faded street sweeping signs were replaced on Adams Ave. in Kensington.
- A new sign was added near University Ave. and 30th St. to clarify the one-hour parking zone.

Pothole Repairs



- Potholes were filled in the 4000 and 4100 blocks of Van Dyke Ave., the 4600 block of W. Talmadge Dr., and the alley behind the 1400 block of Meade Ave.
- Two large potholes on Sussex Dr. in Kensington were repaired.
- Potholes at the end of Cliff St., on Miracle Dr., and in the 4100 block of Wightman St. were repaired.
- A pothole was repaired in the 1500 block of Parrot St.
- A pothole was filled near 38th St. and Polk Ave.
- Two potholes in the 4000 block of Illinois St. were repaired.
- Potholes in the 2800-3300 blocks of 39th St. as well as some in the 3000-3300 blocks of Central Ave. were patched.
- A pothole in the 4600 block of Arizona St. was repaired, as were two more on Adams Ave. in Kensington.
- Two deep and large potholes were repaired in the crosswalk at 7th Ave. at Robinson St.

Sidewalk Repairs



- Sidewalks in the 3000 block of Madison Ave., 3600 block of Mississippi St. and 4200 block of Maryland St. were patched to make them easier to traverse.
- Sidewalk repairs occurred at several locations in the 3000 block of Madison Ave.
- The sidewalk in the 2400 block of Pamo Ave. was temporarily ramped to alleviate tripping hazards.
- A concrete sidewalk and driveway damaged by construction damaged by construction on S. Hempstead Circle.

Strengthening Public Safety

Montclair Park Tagging: Solved



In August, I had the joy of joining with local families and kids to cut the ribbon on the new playground

at Montclair Neighborhood Park. The playground equipment had been unusable for three years since a drunk driver damaged the previous equipment. I was devastated to learn the very next day that the equipment had been extensively tagged.

Just days later, Police Officer Craft saw a moniker written on a juvenile's shoe that matched one of the tags found throughout the park. The teen was promptly arrested.

Fire Safety

- Weeds and overgrown vegetation were removed from a property in the 2000 block of University Ave., again putting it into compliance with the California Fire Code.
- Overgrown brush was removed from a sidewalk near 46th St. and Monroe Ave.
- Property owners of vacant parcels in the 3800 block of 31st St. were notified that overgrown weeds there were in violation of the fire code. The area is being monitored for compliance.
- Brush clearance along Juniper Canyon was determined to be adequate by City staff.
- High brush obstructing the view of merging traffic was removed from Fairmount Ave.
- Fallen tree limbs and brush were cut back from Aldine Dr. near Fairmount Ave.
- Brush on City property near the 42nd St. Canyon was removed.
- Brush and debris were removed from Fairmount Ave.

Streetlight Repairs

- A streetlight at Polk Ave. and Van Dyke Ave. was repaired.
- Streetlights were repaired on 47th St., Hilldale Rd., Beech and 30th, Beech and

Dale, Beech and Fern, Norma Dr., Thorn St. near Fairmount Ave., Myrtle Ave. near Highland, Euclid Ave. near Wightman St. and Auburn, and University Ave. near 47th St. and Highland.

- The courtyard lights at the AT&T building in Hillcrest were replaced, bringing additional illumination to a busy section of University Ave.
- Streetlights were replaced in the 4000 block of Alabama St.
- Streetlights were repaired on the corner of 30th and Beech St., the 4100 block of Alabama St., the 3500 block of 43rd St., the 4300 block of Myrtle St., 39th St. at Myrtle Ave., Meade Ave. near Fairmount, and at First Ave. at Walnut.
- A series of streetlights at Aldine Dr. and Fairmount Ave. are again functioning.
- Multiple street lights were repaired in Kensington.

Graffiti Removal

- Graffiti was removed from the 163 North off-ramp to Robinson Ave.
- Graffiti was removed from a Highland Ave. sidewalk thanks to Urban Corps.

- Urban Corps and District Three again worked together to eliminate graffiti from a utility box on Pennsylvania Ave. and from Brookes Ave.
- Graffiti was also removed from two properties in the 2900 block of El Cajon Blvd.
- Graffiti was removed from the Georgia St. Bridge.

Street Safety

- A pedestrian-activated traffic light will be installed at Park Blvd. and Russ Blvd. by August 2011.
- All-way stop signs are being installed at Texas St. at Polk Ave.
- The traffic signal at Fifth and University Avenues in Hillcrest was repaired.
- The traffic signal at Fifth and University Avenues in Hillcrest was repaired.

- A new V-Calm speed limit sign was installed on Aldine Dr. in Talmadge through coordination with residents and the Traffic Engineering Division.
- Increased traffic enforcement was added on Mountain View Dr. in Normal Heights after reports of dangerous driving speeds.
- Crosswalks near UCSD Medical Center were repainted to promote pedestrian safety.
- The San Diego Police Department cited several vehicles during a speed enforcement operation on Georgia St
- Increased traffic patrols on 31st St. in South Park and on Georgia St. in North Park generated several citations and improved safety.
- The pavement at the intersection of 42nd St. and Polk Ave. will be repaired and striped with crosswalks and stop lines.
- Several curbs along thoroughfares in City Heights were repainted.
- A stop sign was relocated on Kensington Dr. to improve visibility and safety.
- The traffic signals on University Ave. between Florida St. and Bancroft St. were re-timed.
- Bicycle and car lane striping was corrected near the intersection of Washington St. and Cleveland Ave.
- Audible crosswalk signals at Fairmount Ave. and El Cajon Blvd. were repaired

Other Significant Items

- Neighborhood Code Compliance and police addressed code violations in the 3000 block of 46th St.
- A parking lot in the 4100 block of 30th St. was reconfigured for better disabled accessibility.
- A homeless encampment near SR 163 and Sixth Ave. was addressed by the San Diego Police Department.
- San Diego Police increased patrols near Cherokee and 37th St. in response to neighbors' concerns about suspicious activity.
- Swarming bee activity was addressed with the help of County Vector Control at locations in South Park and City Heights.
- A swarm of bees near Violet St. and Pepper Dr. was addressed thanks to District Three's work with County Vector Control.

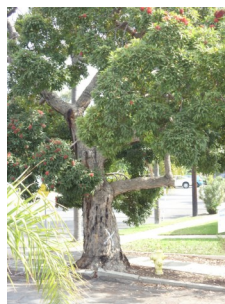
Community Character

Community Clean Ups

- A successful clean up took place on February 6, 2010 in Fairmount Village, Swan Canyon and North Swan Canyon, resulting in the removal of almost 53 tons of junk and debris.
- On February 13, 2010 the Hillcrest Clean T.E.A.M. met under the Hillcrest sign at Fifth and University Avenues and tidied the local area. An additional team combed the alleys in a pick up truck and gathered old mattresses, furniture and other abandoned items.
- A successful clean up took place in Fairmount Village, Swan Canyon and North Swan Canyon, resulting in the removal of almost 53 tons of junk and debris.
- Over 80 bags of rubbish and green waste was removed by the Environmental Services Department after the Council District Three office was notified of an impromptu community cleanup effort in University Heights.
- A successful clean up in City Heights removed 14.35 tons of waste from the neighborhood.
- The Burlingame Annual Dumpster Day on June 19 was a great success. Councilmember Gloria was glad to be able to arrange for landfill tipping passes for the community.
- A home expansion that violated the building code because of its height and encroachment in the 4300 block of Adams Ave. was cited and building plans were modified after neighbors voiced concerns.
- Multiple minor code infractions at a property on Kensington Dr. were investigated and addressed by Neighborhood Code Compliance staff after reports were received from neighbors.
- Building code inspection was performed in the 4400 block of Texas St.
- Illegal street vending responses were coordinated between a City Heights neighbor and SDPD.
- Ave. and Robinson Ave. was cleaned and power-washed.
- Litter removal and weeding was completed in the 4500 block of Boundary St. and the 3000 block of Madison Ave.
- A property in the 1000 block of Madison Ave. was cleared of debris.
- Garbage and rubbish left by evicted tenants on E. Talmadge Dr. was removed.
- A fallen palm tree was removed from the 4700 block of Constance Dr. in Talmadge.
- The construction equipment staging area at Adams Ave. and Edgeware was cleared of overgrown weeds and debris.
- Litter was removed from the northwest corner of Howard Ave. and Idaho St.
- Items left by a homeless encampment were removed from an area near the 2600 block of Montclair St.
- An unused newspaper rack that was the target of repeated graffiti was removed near Lincoln Ave. and Florida St.
- Illegally dumped couches were removed from 35th St. and Adams Ave. and from behind the Mid-City clinic.
- Trash and debris were removed near the 163 on- and off-ramps.
- Debris in violation of the Municipal Code was cleared from a property near Park Blvd. and Polk Ave.
- Tree clippings and construction debris left by a City contractor were cleared from multiple parking spaces near John Adams Elementary School.

- Broken glass and rubbish left at Ward Canyon Park was removed.

Code Compliance

- Administrative Citation Warnings were issued for graffiti to property owners at 43rd St. and Polk Ave. and 45th St. and Highland Ave.
- To combat personal car sales, two areas of 40th St. was added to the proposed "No Car Sales" ordinance that is expected to be considered by the City Council soon.
- Enforcement against illegal yard sales began in January 2010. Neighborhood Code Compliance staff is working in conjunction with the San Diego Police Department to address this ongoing concern.
- An illegally converted garage on Golden Gate Dr. was inspected and reverted to acceptable use.
- Illegal business activity and storage were addressed on 38th St.
- An illegal trailer that was being lived in was moved from the 3000 block of 46th St.
- An illegally parked truck that blocked a sidewalk on Lila Dr. in Talmadge for weeks was moved.

Equal Benefits Ordinance Unanimously Approved

The San Diego City Council unanimously approved an Equal Benefits Ordinance (EBO) proposed by Councilmember Todd Gloria on October 18. The measure ensures that City contractors provide domestic partners of employees the same benefits provided to spouses of employees.

Councilmember Gloria presented the proposed ordinance to his Council colleagues.

"Equality is a priority for the City of San Diego," said Councilmember Gloria. "We have made it clear that companies should provide fair benefits to their employees."

City Hall Hosts Inaugural LGBT Historical Exhibit

Councilmember Todd Gloria officially opened the inaugural display, "A Celebration of San Diego LGBT History," with a ribbon-cutting ceremony at the City Administration Building on July 13.

Presented by Lambda Archives of San Diego and the Harvey Milk Diversity Breakfast, the exhibit ran from July 12 through July 23 and featured approximately 1,100 square feet of historical LGBT community treasures.

"I am proud that City Hall honored the history of the LGBT community by hosting an exhibition by Lambda Archives of San Diego," said Councilmember Gloria. "By highlighting the extensive range of role models who were instrumental in strengthening our community and all of San Diego, Lambda Archives facilitates understanding, education and appreciation among all of our neighbors with this exhibit."

Councilmember Gloria made the arrangements to site "A Celebration of San Diego LGBT History" at the City Administration Building.

"It is long overdue that the LGBT community, like other San Diego communities, showcase our city's diversity, as well as educate those who visit City Hall," said City Commissioner Nicole Murray Ramirez, who initiated the idea and approached Councilmember Gloria for his support of locating the exhibit in City Hall.

Lambda Archives President Frank Nobiletti said, "I hope all of San Diego enjoyed this exhibit. Over the last 40 years, so many lesbian, gay, bisexual and transgender San Diegans made remarkable contributions to our city, while at the same time working for equality. I am glad we can acknowledge their achievements."

Co-sponsors of "A Celebration of San Diego LGBT History" were the Blanchford Cooper Foundation, City of San Diego Human Relations Commission, Gay and Lesbian Fund for San Diego, Greater San Diego Business Association, Harvey Milk Diversity Breakfast, Human Dignity Foundation, Human Rights Campaign, Imperial Court de San Diego, San Diego Pride, San Diego LGBT Center, and the Victory Fund.

The purpose of the EBO is equal pay for equal work. To comply with such a law, a City contractor that offers health insurance and other benefits to employees' spouses must offer equivalent coverage to employees' domestic partners. The EBO will not require City contractors to begin offering benefits not previously offered. If a contractor does not offer benefits to married employees, it is not required to offer benefits to employees in domestic partnerships. San Diego's EBO will apply to any contract entered into, awarded, renewed or extended on or after January 1, 2011.

The ordinance was unanimously recommended for approval by the Committee on Rules, Open Government and Intergovernmental Relations Committee on June 30, 2010, and was endorsed by both the City's Human Relations Commission and Citizens' Equal Opportunity Commission.

The State of California and several cities have similar ordinances in place.

Keeping San Diego Communities Safe

On January 10, 2011, Councilmember Todd Gloria moderated a discussion on hate crimes and public safety at the San Diego LGBT Community Center.

The forum included an overview of the process for investigating and prosecuting potential hate crimes; presentations from the San Diego Police Department, the San Diego County District Attorney's Office, and the Federal Bureau of Investigation; hate crimes scenarios; and member of the public participated in a question and answer session.

"Ensuring all people feel safe and are safe is critical," said Councilmember Gloria. "In 2010, the number of reported hate crimes related to sexual orientation increased in San Diego, so it's imperative that all community members be vigilant and tolerant, and that they understand how such crimes are dealt with by our law enforcement personnel."



Thorn Street Median Improvements are Finally Underway!



On the sunny morning of February 10, Councilmember Todd Gloria, representatives from the Altadena Neighborhood Association, and staff from the City's Engineering and Capital Projects Department broke ground on the Thorn Street Median Improvement Project.

The project is on Thorn Street near 33rd and Felton and will include enhanced aesthetics of the median with landscaping and a community sign; traffic calming; and enhanced pedestrian safety.

"North Park neighbors and the Altadena Neighborhood Association should be recognized for their efforts, relentless spirit, and patience getting the project this far," said Councilmember Gloria. "I look forward to the completion of these improvements, which will beautify the community and make it safer."

Permanent Homeless Services Center Plans Move Forward

Councilmember Todd Gloria was pleased that plans for San Diego's first permanent homeless services and housing facility continued forward on March 1. By a vote of 7-0, the City Council approved the sale of the World Trade Center building located at 1250 Sixth Avenue to the Redevelopment Agency, a necessary step in the process of developing a homeless center.

The City Council also approved the Disposition and Development Agreement (DDA) with Connections Housing for the building's rehabilitation and operations.

"The permanent service center will help move our homeless neighbors off the streets and on to more productive paths. I'm glad we continue to make progress on this critical project," said Councilmember Gloria.

Some issues related to the project's operating budget are still being resolved, and the sale of the building is expected to close escrow this summer contingent on the project being awarded tax credits.

City Seeks to Expand Community Gardens



In response to the continued advocacy of Councilmember Todd Gloria, Mayor Jerry Sanders agreed to develop new guidelines for establishing new community gardens throughout the City of San Diego.

The new regulations will outline how community gardens can be sited on commercially-zoned properties, where they are currently prohibited.

"By permitting community gardens by right in commercial zones throughout the City, the ordinance that we are proposing will eliminate one of the largest barriers to establishing community gardens in San Diego," said Councilmember Gloria.

The Councilmember and Mayor announced the proposed changes with community garden advocates at the New Roots Community Farm in City Heights on February 9.

Safety Tips: How to Avoid Garage Break-ins

1. Don't leave your garage door open.
2. Don't leave the garage door remote in your vehicle. If a thief breaks in to your car and steals the remote, s/he has a way into your home.
3. Invest in a keychain remote opener.
4. Secure your garage door emergency release.
5. Put a deadbolt on any door between the outside of your house leading to your garage and keep it locked.
6. Make sure any door from your garage into your house is as secure as your front door.
7. Install a wide-angle peephole in the door between your house and your garage. You'll at least be able to see what's going on if you hear a strange noise rather than opening the door to find out.
8. Frost or cover your garage windows. Don't let criminals see when your vehicle is gone.
9. Padlock the throw latch on your garage door when you're out of town. If you don't have a manual lock on your garage door, you can use a c-clamp tightened down on each side of the door track.
10. Don't neglect maintenance on your garage door, the door from the outside to your garage, and the door from your garage to the inside of your house; check the frame, locks, hinges and any replaceable items.
