Mid-Year Budget Report

There is continued good news on San Diego's fiscal front. On February 26, 2014, the City's Mid-Year Budget report was brought before the Budget and Government Efficiency Committee, chaired by Council President Gloria. The Mid-Year Report shows a \$50 million projected surplus. It is anticipated that approximately \$23 million of those surplus funds will be spent on pre-filling our other reserve levels, as well as improving neighborhood and community services including: the North Embarcadero Visionary Plan project along Harbor Drive; additional public safety needs including police recruits, lifeguard vehicles, police cameras, and a temporary fire station in the Skyline neighborhood of District Four; and overnight camping at Kumeyaay Campground. "As we see the City's improved finances in future fiscal years, I will continue to advocate for fiscal discipline and well-considered, strategic funding decisions," said Council President Gloria. Recommendations for the Mid-Year Budget Report are expected to come before the full Council for a vote on March 3, 2014.

San Diego's Water Supply

Governor Jerry Brown recently declared a drought state of emergency for California and has called for increased voluntary water conservation. According to the City's Public Utilities Department, San Diego's water supply for 2014 is currently stable because of strong regional water conservation efforts and investments agencies have made in diversifying the region's supply portfolio through the development of local supply projects, water transfers and water storage. City customers' consumption is 15.3% lower today than in 2007. However, ongoing drought conditions in the state could change San Diego's supply conditions. All are encouraged to increase water conservation practices to help our water supply reliability between now and 2015. The City of San Diego's Water Conservation Program provides a free residential water survey to help you save water inside and outside your home, and lower your water bill. This City-wide program is available to single-family and multi-family customers. For additional information about this program, and to make an appointment, call 619-570-1999. Funding for Homelessness Solutions

On February 6, 2014, Council President Gloria outlined his plan to better utilize the City of San Diego's limited resources to help end homelessness. Last year, the number of homeless San Diegans was 5,733. Of that amount, 2,618 live in shelters and transitional housing, and 3,115 are unsheltered, living on the street, in their vehicles or in hand-built structures. Council President Gloria recommended allocating \$1.9 million of General Funds for homeless services in the Fiscal Year 2015 budget that would go towards outcomes-focused services and critical program enhancements resulting in the most effective use of resources and a coordinated system. Council President Gloria asked San Diegans and the business community to contribute to these solutions. "We've seen tremendous participation from local businesses in recent years as they've stepped in to work with the City and service providers, and I will be reaching out to see if we can find additional ways to collaborate toward a solution to end homelessness," said Council President Gloria. "I will work with Mayor Faulconer and my Council colleagues so that these allocations are included in the Fiscal Year 2015 budget, which will be considered this Spring," said Council President Gloria.

Medical Marijuana Dispensaries

On February 25, 2014, the San Diego City Council approved new regulations for medical marijuana dispensaries to ensure legitimate patient access without unnecessary neighborhood impacts. The ordinance passed with a vote of 8-1. The main components to the ordinance are that:

- Cooperatives must be separated from public parks, churches, child care centers, playgrounds, residential care facilities, schools and other cooperatives by 1,000 feet
- · Cooperatives must apply for a Conditional Use Permit with a five year expiration
- · No onsite medical professionals are allowed
- The ordinance includes a 100 foot buffer from residential zones
- · No more than four dispensaries will be permitted to operate in each council district

The ordinance sets the framework for sites that fall outside of the restrictions listed above, but that doesn't mean that dispensaries would actually occupy all of those locations. The ordinance was developed by City staff over the past several months at the City Council's request last April, when the previous mayor proposed far more permissible regulations which would have resulted in increased numbers of dispensaries throughout the City. "This ordinance provides clear and fair rules which will result in access to medical marijuana for legitimate San Diego patients and safeguard neighborhoods from negative impacts associated with dispensaries," said Council President Gloria.
