### **City Ballot Measures on the November Ballot**

Measure E: Qualifications, Vacancy, and Removal for Mayor, City Attorney, and Council: would make it easier to remove and replace city elected officials if they are convicted of a felony, or declared incapacitated.

**Measure F: Probationary** neys: would reduce the probationary period for Deputy City Attorneys from two years to one year.

Measure G: Citizens' Review **Board on Police Practices:** would rename the Citizens' Review Board to the Community Review Board, give Mayor and Council joint oversight, and require the board to review all incustody deaths and officerinvolved shootings.

**Measure H: Purchasing and Contracting Processes for** the City of San Diego: would improve the City's competitive bidding and procure-

ment process for goods and services to ensure the City is able to get the best value for our tax dollars.

**Measure I: Balboa Park and** San Diego High School: would allow the City to negotiate a new lease of dedicated Balboa Park land to the San Diego Uni-Period for Deputy City Attor- fied School District, provided the property continues to be used for a public high school.

> **Measure J: Mission Bay Park** and Regional Park Improvement Funds: would change the regional park fund allocation, so that 65% will go to Mission Bay Park and 35% will go to the City's other regional parks.

Measure K: City's Election **Process for Candidate Elec**tions: would conform the city's election process to the federal and state process by requiring the top 2 candidates to advance from the June primary to the November general election.

Issue With Ink Bleed-Through on Mail-in Ballots

The Registrar of Voters announced that ink used on some absentee ballots in San Diego could bleed through the front side of the ballot and record a "no" vote on one of the City ballot measures. On some ballots. the bubble that voters would fill in to record a "yes" vote

on Measure E lines up on the opposite side of the ballot with the "no" bubble for Measure K. The problem could result in an inadvertent "no" vote, or for a voter's choices to be recorded incorrectly on these two measures.

cess for Citizens' Initiatives and Referendums: would conform the City's process for citizens' initiatives and referendums to align with the state election process by requiring all citizens' initiatives and referenda be placed on the November general election ballot.

Measure M: Affordable Housing: will increase the cap on affordable housing units that can be built in the City of San Diego from the current cap of 10,500 units up to 38,620 additional affordable housing units in the city, without raising taxes.

Measure N: Cannabis Business Tax Measure: will place a tax on all recreational cannabis businesses operating in the City, and will only go into effect if recreational marijuana is approved by voters statewide in November.

At the October 26 meeting, the Rules Committee heard a report by the Performance and Analytics Department on the City's Get it Done App. The Committee then discussed various items including equal opportunity in City contracting, Municipal Code amendments involving redistricting, and the disclosure of business interests for anyone doing business with the City.

The Committee also discussed several other Municipal Code amendments regarding the Rules of Council and the way in which Council meetings are planned and run.

The next Rules Committee meeting is tentatively sched-

uled for Monday, November 14th at 9:00am, but that date and time is subject to change.

# Using the City's "Get It Done" Application

In an effort to make our city government more efficient and accessible to San Diego residents, the City introduced the mobile app called *Get it Done San Diego*. This mobile app is available on your smart phone or accessible through the city's website: <u>www.sandiego.gov</u>.

It allows residents to easily and directly report nonemergency problems and requests for neighborhood improvements.

Some innovative features of the *Get it Done* app include residents being able to share and address concerns with easy accessibility, track the progress of a complaint, and upload photos of the concern that hold GPS embedded information within them.

Whether a resident wants to report the problem with his or her name and contact infor-

mation or anonymously, the *Get it Done* app ensures that the concerns is being handled by the correct department.

If residents have multiple complaints, they are urged to file separate reports for each request, for ease of tracking. The Get it Done app is an easy way for residents to address their concerns and be assured that a city crew will be linked directly to the problem.

### Extended Hours for District One Pools

#### New Housing in District One

#### **Cielo Carmel**

Pacific Highlands Ranch in Carmel Valley is now home to the Cielo Carmel affordable apartments for families. These apartments were constructed as two separate projects. Both projects stand as two-story 12plex buildings consisting of one bedroom, two bedroom, and three bedroom units with on-site amenities.

Amenities include a 1,985 square foot clubhouse, swimming pool, three tot lots, a dog park, community garden, and three laundry facilities. This development will serve local working families.

#### **Torrey Vale**

The brand new Torrey Vale apartment complex is located in The Elms and The Ivy in Carmel Valley. Torrey Vale consists of 28 apartments equipped with central heat/air, blinds, vinyl flooring and carpeting, unit garages, and appliances. Key sustainable energy features of the apartments include solar panels, water-efficient landscaping, and Energy Star appliances.

The community has a laundry room, tot lot, onsite manager, and small community room. The property is 100% affordable and will remain so for 55 years.
