GENTLEMEN:

The undersigned respectfully petition as follows:

READ BEFORE SIGNING

The athletic activities and ball playing have destroyed the safety and ruined the attractiveness of a large part of the beach at Redondo Court life saving station at Mission Beach. No longer can the heads of families and their children and babies enjoy the beach and the bathing at this point because of the danger. It is therefore asked that athletics and ball playing be banned to points of 300 feet north and south of the guard station. It is also asked that ball playing on the sidewalk (seawall) be stopped. The Athletes do not need the protection of the life-guard, but the bathers do. It is a well known fact that before the advent of the ball playing etc. there were hundreds of back country folks with their families using this bathing section. We hope to welcome them back.

What we ask will be no hardship on anyone and will be a great benefit to the beach.
