In view of the traffic congestion in the entire Sun Gold Point Subdivision (particularly at Linda Way and Archer Streets) in LaJolla occasioned by the accumulation of Surf rider cars and the mass assembly of their persons, which could materially interfere with emergency fire, ambulance and police functions in this subdivision; the danger to life and limb of residents caused by car racing in this area by the same surfriders; the obstruction of right of way on pavements to pedestrians by surf boards and assembly of surf riders; the illegal parking of surf riders' cars contributing to increased congestion; the constant harassment to residents that such surf riders cause by their uncontrolled and poor deportment resulting in private property damage, tresspassing, disturbance of the peace and threats to property owners by word, telephone and U.S. Mail( a matter of record with the police department of LaJolla); the rubbish they throw about the streets and pavements of this highly residential R-1 community with high real estate taxes and considerable investment by us the property owners, taxpayers and voters residing in this community; the potential lowering of real estate values as a result of the continued "honky Tonk" atmosphere produced by surf riders cars and persons accumulation and their objectionable deportment; the fact that there are public designated areas available for surf riding; the admission by representatives of the surf board riders that surf riding should be not permitted off residential areas;. therefor we, the undersigned recidents, taxpayers, property owners and voters of this community immediately involved in this problem and the Town Council of LaJolla do hereby petition The Mayor and the City Rean Council of San Diego to close access to the sea from the entire Sun Gold Point Subdivision to Surfriders and to so post this subdivision.
