Kathleen Dang (Congresswoman Jacobs' Office) - Introduced Willow Lance who will be taking over representation for Mission Valley

- Office move district has shifted north so the Congresswoman's office moved to accommodate.
- Congresswoman Jacobs is now in a leadership role with the New (Junior) Congressional Members.

Miles Noel (Councilmember Campillo's Office) – The Councilmember is now representing Mission Valley in the area north of Fryers Rd.

• There will be a Town Hall at USD @ 6:00 Feb 2nd.

Kathy Lippitt – a community member – concerned resident's voices are not being heard.

- attends meetings to have authentic voices of community members heard.
- appeals to City Council's decisions cost \$
- Marijuana projects will have security to protect the project but wants evidence that the community is not being negatively impacted.

Becky Rapp – a community member and Public Health worker – spoke regarding concerns around the city's efforts to change marijuana ordinances.

- Worried about changes to marijuana locations
- Concerned that locating facilities near minor oriented facilities will normalize marijuana in the lives of youth.
- Encouraging us to speak to city reps to keep the current laws in place / not align with State legislature.

G. Information Items

1. Councilmember Stephen Whitburn

Description: Mr. Whitburn will give an update on his priorities representing portions of Mission Valley and will take questions.

Councilmember Stephen Whitburn – SD City Council District 3 – introduced himself and provided the following comments:

- Pleased to be here and pleased that his district now includes parts of Mission Valley
- Apricates the work of MVPG
- Appreciates members of the public who attend their commitment to the community.
- Sees Mission Valley's potential Is looking forward to helping us achieve this
- Challenges:
 - o Homelessness
 - we are getting people off the streets and into shelter but #s are increasing.

- working closely with Mayor's office on Ordinance restricting camping on public property (parks, canyons, and riverbed).
- align law enforcement with the problem at hand.
- provide alternative places for people to go (Safe Sleeping Initiative) and expanding existing tent shelters.
- Drug addiction and Mental Health issues
 - proponent of conservatorship through "Care Court"
 - direct individuals to services
 - SD County is stepping up to provide add'l care.

Questions (Q) / Public Comments (C) and Response (A)

Q: Scope of Homeless population - 8K County, 4K in city (1.8K unsheltered in downtown). **A:** Unsheltered are target population for new program.

Q: Will this increase issues Downtown / doesn't every neighborhood need to do their share? **A:** Downtown is a pilot program and agrees we need more services throughout the city. Looking to prove concept.

Q: Scope of property needed to house 1.8k is large? **A**: Shelter tents can accommodate a few hundred with safe sleeping in large but standard parking lot – will need space but not outrageous

Q: How will you get people there / how long can they stay? **A:** City to provide transport and location will have onsite service providers working to support move to housing. Meals etc. will be included.

C: SDSU West could be a good opportunity to use Graduate Students to support this kind of program. **A:** The city would welcome partnership – this is "all hands-on deck" situation

Q: Is there permanent housing available as 'next steps' for this program? **A:** Not yet but that is the goal. Working to add housing in the city as quickly as possible. Takes a long time to get permits approved through the city but the city has opened an additional 44 permit review positions and has contracted with 2 third party plan review companies to improve permitting times.

Thanks extended to councilman Whitburn.

H. Action Items

1. Council Policy 600-24 Reform Update – Michele Addington

Description: Discussion and potential action to take steps necessary to achieve future formal recognition of the MVPG pursuant to the newly adopted Council policy 600-24 related to community planning groups.

Michele Addington outlined required next actions.

- Modify our ballots (2 year becomes permanent)
 Amend pre-meeting attendance requirements.
- We will be required to take care of our own documents.
 - Using a Website or Facebook (others are doing this)
 - City will still require our Agendas.
- Waiting for templates which are due back in third quarter.
- Need a sub-committee to review template / modifications.
- Present any possible changes to the group for approval.
- 1st quarter 2024 the docs from ALL city CPG will go to the council.
 - $\,\circ\,$ Our bylaws are in good shape and should not require much modification.
- March 2024 election will need to follow new rules advertise throughout our district.

• If you have time / interest to participate please volunteer – we should meet beginning next month.

Discussion:

- Concerns that Facebook opens up Board Member participation in their private lives.
- Businesses like 1-on-1 or Go Daddy can support required documentation but would cost funds to host / maintain.
 - Could include public forums.
- Recommend making a 'proof of concept' on options to consider.
- Ask city council persons if they will support us financially.

The discussion resulted in no action being required by the group at this time therefore **no motion was made on the item**.

1) Public Health, Safety and Welfare – Elizabeth Leventhal

- Point in time count occurred last week with numbers due in May.
- Hopes Councilman Whitburn's ideas take a compassionate approach and works closely with SD River foundation etc. on Mission Valley unique needs.
- C: Homeless are camping on overpass on CalTrans property.
- **C:** Mayor's office spoke to the importance of looking at this through a compassionate lens. Anticipate full force push back from Advocates to the program and wants to partner with neighborhoods to develop grass roots support.
- **C:** There are lawsuits on the books regarding homeless issues. **A:** The city is aware and ensuring proposals are not in violation but are also looking to develop new ordinance to address the issues as we know them today.
- **C:** Recommendation on an under used property in Mira Mar challenges in property ownership however city can look into it.
- **C:** Property developers experience crime element however slow city response requires a stronger hand this could be one off situation

2) MV Stadium Redevelopment – Kaye Durant

- River park is advancing no firm date on target yet.
- Stadium is being used for Concerts and Events
- Needs to address traffic issues / signage.
- Looking at proposals for Innovation District have selected Phase 1 housing developers.

3) Subcommittee on CP 600-24 – Michele Addington

- CPC end of COVID requires in person meeting for the CPC.
- Capital Improvement Program will need to start in March (annual survey about Capital Improvement Projects).
- Discussed 2021 and 2025 programs.
