HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing ***9** on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial ***6** on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the <u>webform</u>, indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer <u>website</u> for further instructions.

<u>Written Materials</u>: Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

ITEM 1: CALLE DE LA GARZA REMODEL – PROJECT NO. 696515

Staff: Hector Rios City Council District: 1 Plan Area: La Jolla

Site Development Permit for a proposed 1,229 square foot 2nd story addition with deck and 75 square foot 1st floor addition to an existing 7,628 square foot single family residence at 2350 Calle de la Garza. The 0.56-acre site is located in the LJSPD-SF Base Zone and the Coastal (Non-Appealable) Overlay Zone and Coastal Height Limitation Overlay Zone within the La Jolla Community Plan area. A 15162-consistency evaluation was conducted with the previously adopted "2014" Calle de la Garza Remodel Mitigated Negative Declaration (LDR No. 341630). The evaluation substantiates the conclusion that supports a determination that no subsequent document is required. Report No. <u>HO-23-014</u>.

ITEM 2: 3070 REYNARD WAY - PROJECT NO. 1061476

Staff: May Rollin City Council District: 3 Plan Area: Uptown

Conditional Use Permit (CUP) to expand the operation of a fuel station and 2,400square-foot market. The project possess a Type 20 Alcoholic Beverage Control (ABC) Liquor license scheduled to expire end of April 2023 and is applying for a Type 21 Alcoholic Beverage Control (ABC) Liquor license to allow for the sale of distilled spirits in addition to beer and wine. The 0.23-acre site is located at 3070 Reynard Way in the Commercial Neighborhood (CN-1-3) Base Zone within the Parking Standards Transit Priority, Transit Priority, Airport Land Use Compatibility, Airport Approach, ALUCP Airport Influence Area, ALUCP Noise Contours (SDIA, 60-65 CNEL), FAA Part 77 Noticing Area Overlay Zones of the Uptown Community Plan. This project is exempt from the California Environmental Quality Act (CEQA). Report No. <u>HO-23-015</u>.

ITEM 3: 3737 31ST STREET – PROJECT NO. 1048505

Staff: Carrie Lindsay City Council District: 3 Plan Area: North Park

Tentative Map to consolidate two existing lots into one parcel for the creation of four residential condominium units currently under construction under a separate permit, and a waiver of the requirement to underground existing off-site utilities. The 0.143-acre site is located at 3737 31st Street in the RM-2-5 zone within the North Park Community Plan area. Council District 3. This project is exempt from the California Environmental Quality Act (CEQA). Report No. <u>HO-23-016</u>.
