To Whom It May Concern:

Leighton and Associates, Inc. (Leighton) has been retained by Warmington Residential California, Inc. to provide geotechnical services for the duration of the project. This letter is provided as formal notification of our assumption of Geotechnical Engineer of Record (GEOR) for the project.

We have reviewed former consultants' site-specific geotechnical report provided to our office, along with pertinent published geologic maps/reports and a 20-scale concept plan for a 42-unit multi-family residential development, prepared by Rick Engineering Company (REC, 2020). We have also completed a field percolation testing study on the site for use in BMP design (Leighton, 2020). A list of the above plans and reports is attached (see *References*).

The geotechnical report prepared by AGS addressed a former 23-unit townhome design concept by SummA Architects (SummA, 2019). We are in general agreement with the AGS scope of work, findings, conclusions and recommendations documented in their report, and consider the information generally applicable for use in design and construction of the current project concept (REC, 2020).

Future Leighton services may include but not be limited to the following:

- Performance of grading and structural design plan reviews,
- Prepare revised geotechnical recommendations for modified or new design elements,
- Response to agency review comments.
- Geotechnical observation, testing and reporting for rough and precise grading earthwork.

We reserve the right to revise existing recommendations to address changes in grading and construction design plans, and/or, to address encountered during grading which significantly differ from those described in the referenced reports.
