Coastal Development Permit and Site Development Permit to authorize a 444 square-foot addition to an existing one-story, 2,479 square-foot single-family residence for a total of 2,923 square feet at 5692 Dolphin Place. The 0.17-acre site is in the RS-1-7 Zone, Coastal (Appealable Area) Overlay Zone, Coastal Height Limitation Overlay Zone, First Public Roadway, Parking Impact Overlay Zone (Beach and Coastal Impact), Residential Tandem Parking Overlay Zone, Transit Area Overlay Zone, Geologic Hazards Zones 47 and 53, FEMA 100-year Floodplain, and contains environmentally sensitive lands (sensitive coastal bluff) within the La Jolla Community Plan and Local Coastal Program Land Use Plan (Community Plan) areas.
