### HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

<u>In Person for Agenda Items and Non-Agenda Public Comment:</u> Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

**Please Note:** Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

### **HOW TO PROVIDE WRITTEN COMMENTS:**

For Agenda Items and Non-Agenda Public Comment: Submit using the webform, indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer website for further instructions.

<u>Written Materials:</u> Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

### **Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3<sup>rd</sup> Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Please note: Approximately one hour prior to the start of the Hearing Officer meeting, the documents will be available just outside the meeting location as identified herein in a binder labeled "Late-Arriving Materials". Late arriving materials received during the Hearing Officer meeting are available for review by making a verbal request of the Legislative staff at the meeting location.

ITEM 1: SMITH RESIDENCE NEW GARAGE - PROJECT NO. 1048449

Site Development Permit for the construction of a new detached 1,940-square-foot four-car garage with storage mezzanine at existing single-family residence. The 1.45-acre site is located at 414 La Crescentia Drive, in the RS-1-4 zone, Coastal Overlay Zone (Non-Appealable Area 1), Coastal Height Limitation Overlay Zone, Coastal

Parking Impact Overlay Zone, Transit Priority Area, North Island Naval Air Station, and San Diego International Airport Land Use Compatibility Overlay Zone (ALUCOZ), Airport Influence Area (AIA) Review Area 2, Federal Aviation Administration (FAA) Part 77 Noticing Area and Environmentally Sensitive Lands within the Peninsula Community Plan. The project is exempt from CEQA pursuant to CEQA Guidelines Section 15303 (e), New Construction or Conversion of Small Structures. Report No. HO-23-044.

# ITEM 2: 821 SAN ANTONIO PLACE - PROJECT NO. 1057682

Staff: Robin MacCartee City Council District: 2 Plan Area: Peninsula

Coastal Development Permit to partially demolish an existing 6,380-square-foot, two-story single dwelling unit and replace it with a new 6,115-square-foot, two-story, single dwelling unit with a two-car garage and a new, detached, 796-square-foot, two-story Accessory Dwelling Unit (ADU). Site improvements include the removal and replacement of existing retaining/site walls, a new swimming pool, the removal of encroachments on San Diego Unified Port District public trust land, landscaping, irrigation, and landscape-related improvements. The 0.29-acre site is in the RS-1-7 Zone and Coastal Overlay (Appealable) Zone within the Peninsula Community Plan. Council District 2. This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (Existing Facilities), Section 15302 (Replacement or Reconstruction), and Section 15303 (New Construction). Report No. HO-23-045.

### ITEM 3: MATTAMAL ACESSORY DWELING UNIT - PROJECT NO. 695193

Coastal Development Permit to amend Coastal Development Permit No. 2181750 for the construction of a new 430-square-foot accessory dwelling unit above an existing detached two-car garage on a site with an existing duplex. The 0.08-acre project site is located at 5018 and 5018 1/2 Narragansett Avenue in the RM-2-4 zone and the Coastal Overlay Zone (Appealable area) within the Ocean Beach Community Plan. This project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15303 (New Construction or Conversion of Small Structures). Report No. HO-23-046.
