Please be advised that the City of San Diego Solid Waste Local Enforcement Agency (LEA) will be holding an informational public meeting in compliance with Public Resource Code §44004 regarding a new proposed Solid Waste Facility Permit for IMS Recycling Services, Inc, SWIS #37-AB-0029. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the City of San Diego, including all transfer/processing facilities.

Description of Project and LEA's Determination

IMS is requesting a Solid Waste Facility Permit for their operation to allow processing of material with greater than 10% putrescible waste. The facility operates on a 1.53 acres site and plans to accept 750 tons per day of curbside and other source-separated recyclables including; cardboard, paper, metal, plastic, glass, wood, and textile. The LEA has accepted the permit application package as complete on June 29, 2018 and will be drafting a proposed Solid Waste Facility Permit.
