CURRENT PLANNING COMMISSION DOCKETS AND BROWN ACT COMPLIANCE - COVID-19 PUBLIC SERVICE ANNOUNCEMENT REGARDING MEETING ACCESS AND PUBLIC COMMENT.

On September 13, 2022, the San Diego City Council declared an existing proclaimed state of emergency and amended Assembly 361 and that their findings applies to all boards, commissions, and committees of the City of San Diego.

City Council District: 2 **Plan Area**: Pacific Beach **Staff:** Bryan Hudson

Coastal Development Permit, Site Development Permit, Tentative Map, and Public Rightof-Way Vacation to demolish an existing single-family residence and subdivide an existing lot into three lots for the construction of a three-story, 2,016 square-foot residence; a two-story, 2,016 square-foot residence; and a two-story, 2,030 square-foot residence, with a Companion Unit and Junior Unit on each lot; and to vacate a portion of Haines Street for a small lot subdivision. The 0.186-acre site is in the RM-1-1 Zone, the Coastal Overlay Zone (Non-Appealable) and within the Pacific Beach Community Plan area. Mitigated Negative Declaration No. 669397 and a Mitigation Monitoring and Reporting Program was prepared. The decision to approve, conditionally approve, modify, or deny the requested actions will be made by the City Council at a future public hearing. Report No. <u>PC-22-037</u>

ITEM 2: CALIFORNIA TERRACES PA61 (LOT 1) - PROJECT NO. 690358

City Council District: 8 Plan Area: Otay Mesa Staff: Benjamin Hafertepe

A Master Planned Development Permit (MPDP), Neighborhood Development Permit (NDP), Vesting Tentative Map (VTM), Site Development Permit (SDP), Rezone, and Community Plan Amendment to amend the previously approved MPDP, NDP, VTM, & SDP to construct 79 multi-dwelling units in 12 buildings totaling 165,593 square feet.

The project site is proposed to be rezoned from CC-1-3 and AR-1-1 to RM-2-5, and the Land Use designation is proposed to change from Community Commercial-Residential Prohibited to Residential-Medium (15-29 dwelling units per acre). The 4.46-acre site is located on Lot 1 at the southeast corner of Caliente Avenue and Otay Mesa Road in the CC-1-3 and AR-1-1 Zone within the Otay Mesa Community Plan Area.
