The updated Mission Valley Community Plan is proposed to replace the 1985 Mission Valley Community Plan, with an accompanying rezoning to citywide zones. The draft under consideration provides a comprehensive policy framework for growth and development over the next 20 to 30 years. Consistent with policy direction in the General Plan and the Climate Action Plan, the draft community plan proposes density increases along transit corridors and contains policies to provide a multi-modal transportation system to promote active transportation and increase transit use. The draft community plan includes a mix of uses, residential densities, nonresidential intensities, and urban design policies to foster transit-oriented development. A Program Environmental Impact Report (PEIR) has been prepared and circulated for public review. A Final PEIR along with the responses to comments will be completed and provided for review and consideration. Report No. PC-19-050; Attachments.
