Appeal of the Hearing Officer's July 10, 2019, to deny the Neff Rental Variance. The 3.27-acre project site is located at 6144 Federal Boulevard, immediately south of State Route 94, in the CO-2-1 Zone, within the Encanto Neighborhoods Community Plan. The site is developed with an existing equipment rental establishment, operating as "United Rentals". The variance would allow the electrification an existing 10-foot tall interior-facing fence surrounding the site, which is located behind an existing non-electrified perimeter fence.
