Del Mar Highlands Estates Amendment: Site Development Permit (SDP) and Planned Development Permit (PDP) to amend SDP No. 1828039 and PDP No. 1783449 to construct 20 multi-family affordable housing dwelling units and six market rate dwelling units for a total of 26 multi-family dwelling units within five buildings. The 1.80-acre site is located at 14163 Old El Camino Real in the AR-1-1 (Agricultural-Residential) and OC-1-1 (Open Space- Conservation) Zones within the Pacific Highlands Ranch Subarea Plan area. The site is a part of Unit 10, Lot 149, of the Del Mar Highlands Estates (DMHE) project that was approved in 1997. The project site is adjacent to the Multiple Habitat Planning Area (MHPA) open space to the southeast on a separate parcel. All surrounding habitat (MHPA and non MHPA) has been conserved as a result of implementation of DMHE project. ITEM-2: *CALIFORNIA THEATRE SDP/NDP/NUP/TM

City Council District: 3 Plan Area: Downtown

Site Development Permit (SDP), Neighborhood Development Permit (NDP), Neighborhood Use Permit (NUP), and Tentative Map (TM) for the construction of a 41-story, 431-foot tall mixeduse development known as California Theatre, comprised of 336 dwelling units, 190 hotel guest rooms, 3,686 square feet of commercial space, and 194 parking spaces located on the 25,101 square foot site at 1122 Fourth Avenue on the north side of C Street between Third and Fourth avenues in the Downtown Community Plan area. The request includes a SDP for demolition of a historical resource (California Theatre, HRB Site No. 291), NDP for eight deviations from the development regulations and the construction of private structures in the public right-of-way, NUP for a comprehensive sign plan, and TM for the creation of 336 residential condominiums units. The Project is within the scope of the previously certified Downtown Final Environmental Impact Report as amended and no additional environmental document is required under the California Environmental Quality Act. ITEM-3: BARRIO LOGAN COMMUNITY PLAN UPDATE - WORKSHOP

Staff: Michael Prinz

Barrio Logan is one of the oldest and most culturally rich urban neighborhoods in San Diego. The community comprises approximately 1,000 acres located south of downtown San Diego, west of Interstate-5, east of the Unified Port of San Diego, United States Naval Base San Diego and San Diego Bay, and north National City.

The Barrio Logan Community Plan Update (CPU) was adopted in 2013 following a five-year community engagement process; it was repealed by referendum in 2014. In 2020, the Barrio Logan Community Planning Group (BLCPG), Environmental Health Coalition, and the Ship Building/Repair Industry reached an agreement to recommend land uses that would result in the 2013 plan being resolved. Staff is working with the BLCPG and the community to review the agreement recommendations and identify any revisions or additions that could be incorporated into the updated Community Plan. Staff will provide a review of the Plan Update process and seek input from the Planning Commission on key land use, mobility, and public space recommendations developed through the CPU process.
