DIRECTOR'S REPORT

PJ FitzGerald, Assistant Deputy Director of Development Service Department shared some great news regarding the new hybrid online permitting system that was launched last Monday, May 4th. She stated that as we continue to move forward under the State of Emergency protocols, Development Services is continuing to enhance virtual capabilities; our public participation has been enhanced through the public call-in capabilities that we have today on our third Planning Commission virtual meeting. On May 4th, DSD began accepting permits online for all new projects expanding our existing digital permitting process that was currently available for a limited number of permit types. Over the last several weeks, DSD has been developing a hybrid solution that will enable customers to submit their plans online, to help meet safety protocols for customers and employees alike in response to the COVID-19 pandemic. It will be a permanent change moving forward until digital permit review is implemented later this year. The online permitting will be a gradual transition to ensure flexibility for customers and plan reviewers as we roll this new system out. During this time, DSD will continue allowing an optional paper submittal for the next several weeks during the transition period so that customers and employee can adjust to this new system. Resubmittal for projects that has started in paper will continue in paper as we evaluate options during the transition to digital. Customers will be allowed to bring in paper plans and documents to DSD for plan review meetings, but final submission will be in electronic format. The user guide and video were developed to help customers understand on how to use online permitting tool and it is available on DSD webpage. In closing, she announced that as of yesterday we received more than 450 new applications using the new system; the applicants and the staff are quickly adapting to this change.
