Dear Ms. Pham,

This Archaeological Resources Report Form presents the results of a cultural resources constraints study conducted by Red Tail Environmental (Red Tail) for the Pressure Reducing Stations Upgrade Phase 1 Project (project). The project is 0.125-acres and is located in Carmel Valley, San Diego, California. The City of San Diego is the lead agency for the project (City). This study was performed in accordance with the California Environmental Quality Act (CEQA) and the City of San Diego Historical Resources Guidelines of the Land Development Manual to identify cultural resources constraints and determine the presence or absence of potentially significant prehistoric and historic resources or buildings within the project area.

A record search conducted at the South Coastal Information Center (SCIC) was positive for previously recorded resources within the project area, as the record search revealed that one resource, P-37-017122/CA-SDI-16653 was documented as existing within the project area, specifically within the access road. An archaeological survey of the project area and the immediate vicinity along the south side of Carmel Valley Road resulted in the identification of a low-density scatter of marine shell remains. A previously conducted archaeological survey along Carmel Valley Road in 1999 identified shellfish remains along the north and south sides of Carmel Valley Road and determined them to be archaeological elements associated with P-37-017122/CA-SDI-16653. The current survey effort did not identify any additional cultural artifacts besides the shell scatter. The survey effort did not observe any indications of potentially intact subsurface deposits within the project area.

It is recommended that if ground disturbance is required, including vegetation removal within the access road that causes soil disturbances, within the site boundary of P-37-017122/CA-SDI-16653, then further evaluation of the site is needed to identify if the project will impact the resource. Ground disturbance within P-37-017122/CA-SDI-16653 could cause constitute a significant impact under CEQA and would require mitigation. Mitigation would likely consist of data recovery excavations, sampling the impacted area, as well as construction monitoring. P-37-

017122/CA-SDI-16653 was previously tested and was identified as a large prehistoric habitation site and human remains have been identified within the site. However, the previous archaeological testing of the site took place north of Carmel Valley Road. Therefore, it is unknown if intact subsurface deposits are present within the project area.

Archaeological and Native American monitoring is recommended during the execution of ground disturbing activities associated with the demolition and backfilling of the pressure reducing station, outside of the boundaries of P-37-017122/CA-SDI-16653. In addition, due to the presence of previously recorded site P-37-017122/CA-SDI-16653, it is recommended that vehicles with rubber tires only, no tracks, be used and no grading of the road occur within the previously recorded boundaries of P-37-017122/CA-SDI-16653. Vegetation removal within the site boundaries should not disturb the soil and should be limited to above ground removal only.

Additional excavation work beyond the scope of the proposed project plan will require additional archaeological work to assess the potential for subsurface deposits.

I. PROJECT DESCRIPTION AND LOCATION

The project is proposed by the City of San Diego Engineering and Capital Projects Department (ECP). The objective of the proposed project is to abandon an existing Pressure Reducing Station (PRS) which is no longer in use. The proposed project would be considered a one-time maintenance event, and would not need to provide clearance for long-term, ongoing maintenance.

In order to abandon the existing Pressure Reducing Station in place the contractor will remove and dispose the existing pressure reducing control valves, gate valves, dresser couplings, access manhole frame and cover, gate well covers and any piping inside vault. Then it will break the bottom of the existing concrete vault slab which will be fill with soil. This procedure will be within the existing disturbed area, the work on site should not exceed 8 feet in depth. The Contractor shall abandon the 16 in AC water main and the 8 in AC private water in the vegetated area and slurry fill it. The Contractor shall disconnect the pressure reducing station from the 24 in transmission main and blind flange the end 16" by 24" reducer, which will require a 5 ft X 5 ft access pit. The Contractor will also have a dump truck to haul off any debris from any demolition. A trailer for the excavator and a utility truck for hand tools. The access road will be cleared from vegetation,

The project area is in Carmel Valley, in the northern portion of the City of San Diego, west of the interchange of Interstate (I-) 5 and State Route (SR) 56. The PRS is located south of Carmel Valley Road, east of Portofino Drive, and west of Pointe Del Mar Way. The project area is located east-northeast of Los Peñasquitos Lagoon and north of Peñasquitos Creek, and is shown on the *Del Mar, California* USGS 7.5-minute quadrangle within Townships 14 South, Range 4 West, Section 25 (Figures 1, 2, and 3).

The project area includes both the pressure reducing station and the access road, and consists of 0.125 acres (Figure 3). As the project consists of the demolition of one pressure reducing station and two associated AC water lines, there are no anticipated indirect or cumulative impacts that would necessitate a larger project area outside of the direct project area.

II. SETTING

Natural Environment (Present)

The project area ranges between 19 and 29 feet above mean sea level along the north bank of Carmel Valley overlooking Los Peñasquitos Lagoon to the west-southwest and Peñasquitos Creek to the south. The project area is situated upon the base of a south-facing marine sandstone terrace. The project area itself is largely undeveloped but appears to have been highly modified from the original native landform. Access to the project area is via a small unnamed access road that connects to Carmel Valley Road. The area south and west of the project area is undeveloped, consisting of protected riparian and lagoonal environments within Torrey Pines State Preserve. Areas east of the project area consist of a mix of commercial developments and highway interchanges, and areas north of Carmel Valley Road have been developed into residential neighborhoods.

Natural Environment (Past)

A review of the prehistoric, ethnographic, and historic background for the project area can be found in the San Diego Municipal Code: Land Development Code – Historical Resources Guidelines, Appendix A – San Diego History (2001).

III. STUDY METHODS

Methods used for this constraints analysis included a search of existing records and an intensive field survey. The records search of the California Historical Resources Information System (CHRIS) held by the South Coastal Information Center (SCIC) was conducted on April 16, 2021. The search included the project area and a radius of one-mile (mi.) around it. Historic aerial photographs and historic USGS topographic maps of the project area were consulted from historicaerials.com and the USGS Historic Topographic Map Explorer, respectively. The record search confirmation is included in Appendix A.

A record search of the Sacred Lands File held by the Native American Heritage Commission (NAHC) was requested on April 16, 2021 (Appendix B).

The field survey was conducted on April 22, 2021, by Red Tail Archaeological Field Director Spencer Bietz and Native American Monitor Anthony LaChappa. The archaeologists transected the proposed impact areas and access routes in 5-meter intervals when topography and vegetation allowed. All exposed sediments were examined for cultural resources existing in surficial contexts and for indications of potentially intact subsurface deposits through changes in sediment colors and consistencies. Photographs of the impact area and access route for each outfall location were taken from various angles. Any newly or previously identified sites will be recorded on California Department of Parks and Recreation (DPR) 523 site record forms and will be submitted to the SCIC for update or assignment of trinomial designators (Confidential Appendix C).

IV. STUDY RESULTS

Background Research

SCIC Record Search Results

The records search of the CHRIS at the SCIC resulted in the identification of one hundred seventy (170) cultural resources reports within a one-mile radius of the project area. Six of the reports encompassed all or portions of the project area (Table 1). Descriptions of the cultural resource studies within the records search radius are provided in Appendix A: Table 1.

The record search indicated that one hundred seventy-four cultural resources have been recorded within one mile of the project area, consisting of prehistoric and historic archaeological sites, built environment resources, and prehistoric isolates. The full record search results are included in Appendix A:Table 2. One previously recorded resource, P-37-017122/CA-SDI-16653 was documented as existing within project area, specifically, within the access road. This resource was originally recorded using two separate designations (P-37-000195/CA-SDI-195 and P-37-004629/CA-SDI-4629) which were later combined and redesignated using a new resource number (P-37-017122/CA-SDI-16653).

No historic addresses were identified either within the project area or within the one-mile search radius.

One resource, P-37-017222/CA-SDI-16653, intersects the access road within the project area. The resource consists of two previously recorded resources, P-37-000195/CA-SDI-195 and P-37-004629/CA-SDI-4629, which were merged into a single resource in 1999. The resource was

originally recorded as site W-20 by Malcolm Rogers in 1920. Rogers described the site as a large shell midden site containing lithic tools, ground stone artifacts, and hearths along the border of a slough proceeding upwards to the crest of a knoll overlooking the lagoons to the south. The site was partially excavated in 1968 by San Diego Gas and Electric. A trench was excavated to a depth of eight feet below surface, and San Diego Museum of Man archaeologists recovered a partial inhumation along with an associated hearth feature and shell midden. The trench was located just west of Interstate 5 and north of Carmel Valley Road (Davies 1968). The site was more extensively documented and tested by Smith and Moriarty in the early 1980s. Smith and Moriarty documented the resource as a large shell midden containing lithic tools, debitage, bone wastes, burials, and ceremonial items, with radiocarbon dates from marine shell remains extending between 2355-7140 years before present (Smith and Moriarty 1985). A total of seventeen discrete loci were identified within the site, comprising nearly the entire crest of a large knoll just west of Interstate 5. The site was largely destroyed in the early 1980s during the creation of residential neighborhoods along Caminito Pointe Del Mar and Caminito Carmel. Additional site visits and intensive pedestrian surveys have shown that cultural elements associated with the site are still within in-situ contexts near the original site area:

- In 1999, a redeposited shell midden complex containing at least four types of marine shellfish species and lithic tools was identified along the sides of Carmel Valley Road between Portofino Road and Interstate 5 (Williams 1999). The scatter was identified along a 75-meter-long span on the north side of Carmel Valley Road and within a span measuring approximately 300 meters along the south side of the road (see Figure 4).
- In 2005, marine shell remains and lithic artifacts were observed along both sides of the Interstate 5 southbound offramp for Carmel Valley Road (Laylander and Palette 2006).
- In 2011, subsurface testing was performed for a proposed Caltrans sound wall along the extreme eastern edge of the site. Forensic canines were used to identify possible locations of human remains. Six shovel test pits measuring 50 x 25 cm and four test units measuring 50 x 50 cm were excavated, resulting in the recovery of moderate amounts of marine shell and one mano. Most of the recovered cultural material was present between 65 cm and 110 cm below surface (Laylander and Wolf 2011).
- In 2012, archaeologists from California State Parks observed a large site containing at least four features composed of fire-affected rock (FAR), a scatter of lithic debitage, 2+ lithic cores, a scatter of marine shell remains, and dark midden soil while monitoring the installation of permanent boundary markers to delineate the boundary of Torrey Pines State Natural Reserve (Collier and LaPierre 2012).
- In 2016, a portion of the resource was revisited and updated by S. Foglia and B. Spelts for the Coastal Reliability Project. The site visit resulted in the identification of multiple scatters of marine shell fragments near the intersection of Carmel Valley Road and Portofino Road, containing *Chione sp.*, *Ostrea sp.*, and *Argopecten sp.* One lithic tool and one lithic manuport were also identified (AECOM 2016).

Native American Heritage Commission Record Search Results

The NAHC responded that the record search of the Sacred Lands File was negative. The NAHC provided contact information for 20 tribal organizations that may have additional information on the project area. All correspondence pertaining to the NAHC is included in Appendix B.

Historical Research Results

Aerial photographs from 1953 through 2016 and USGS Topographic Maps from 1903 to 2018 (historicaerials.com 2021) were examined to identify if ground disturbances have taken place within the project area.

The 1953 aerial photograph shows Carmel Valley Road already having been constructed, although the majority of the surrounding area is still largely undeveloped. Several roads are present to the northwest, appearing to be the preliminary planning stages of a small community. Aerial imagery from 1964, 1966, 1967, 1978, 1980, and 1981 show much of the area staying undeveloped. Interstate 5 is developed during this time frame and is visible east of the project area. The streets northwest of the project area appear to have been developed into a small residential community. Portofino Drive is developed between 1967 and 1978. Imagery from 1982, 1983, 1984, and 1985 display the grading and development of the knoll north of the project area for residential housing, along with the creation of associated streets Caminito Pointe Del Mar and Caminito Carmel. Imagery from 1983, 1984, and 1985 also show the project area and the southern and northern borders of Carmel Valley Road as being heavily graded. Within this time span, aerial imagery depicts the project area as being completely devoid of any vegetation, and the access road to the PRS is visible starting in 1984. Within imagery from 1985, 1986, 1987, 1988, 1989, 1990, and 1991 additional residential and commercial development is seen within the outer areas along Portofino Drive, Pointe Del Mar Way, and areas east of Interstate 5. Imagery from 1993, 1994, 1995, 1996, 1997, 1998, 1999, 2000, 2002, 2003, and 2005 show nearly all development activities focusing upon areas east of Interstate 5, with mixed commercial and residential housing being developed between State Route 56 and Del Mar Heights Road, and primarily commercial development occurring south of State Route 56. Imagery from this time frame also shows the construction of the new State Route 56 and its associated on- and off-ramps connecting to Interstate 5. Imagery from 2010, 2012, 2014, and 2016 show fewer development activities occurring within the vicinity of the project area. Since being graded and having a dedicated access road created in the early 1980s, the project area remains unkept through this time frame, with vegetation regrowing in previously graded areas. No visible structures are evident in imagery between 1983 and 2016.

USGS topographic maps from 1903, 1909, 1913, 1920, 1927, 1929, 1934, 1940, and 1942, show the vicinity of the project area within Soledad Canyon. The area is largely undeveloped, with only a few mapped structures and several established roads. Carmel Valley Road is visible within topographic maps as early as 1903 and appears to exist within its present-day alignment. Maps from 1943, 1954, 1955, 1959, 1960, and 1966 show the majority of development occurring northwest of the project area with the creation of several new residential streets and houses. Topographic maps from 1970, 1976, and 1976 show additional residential development occurring north and northwest of the project area. Interstate 5 is also visible, starting in 1970. The topographic map from 2000 large amounts of developed residential and mixed-use areas north, northwest, and northeast of the project area. State Route 56 is not visible within the 2000 topographic map, however it is visible within maps from 2012, 2015, and 2018. These last three maps show the present-day extent of residential and mixed-use developments surrounding the project area on all sides except to the south, southeast, and west.

All aerial imagery starting from 1953 along topographic maps as early as 1943 show the Atchison Topeka & Santa Fe Railroad line along the west side of Soledad Valley. A second course along the east side of Soledad Valley is also visible within topographic maps between 1903 and 1943

and within aerial imagery from 1953 through the present day. The eastern course appears to represent additional sections of the former railroad bed recorded as P-37-036419 as it proceeds north-northeast from the southern end of Soledad Valley into the project area, turning west-northwest upon crossing Carmel Valley Road. Topographic map depictions of the railroad label it as Surfliner or R.R. (Surf), and depict the track as passing along the north side of the slough on the west side of the project area. Aerial imagery of the railroad show the grade bed as passing directly through the project area. The portions of the railroad north of Carmel Valley Road fade from view within aerial imagery after 1983, however the grade bed within the eastern portion of Soledad Valley is visible within imagery up through 2016.

Field Reconnaissance

The project area lies upon the north bank overlooking Los Peñasquitos Lagoon to the west-southwest and Peñasquitos Creek to the south. The PRS is located at the base of the bank and is accessible via an unpaved access road that proceeds from the PRS east-northeast towards Carmel Valley Road. The area surrounding the PRS primarily contained riparian vegetation, including willow and mulefat. Open areas away from the PRS contained a mixture of riparian, coastal sage scrub, and wetland vegetation. Several areas surrounding the PRS were overly saturated and standing water was visible upon the surface (See Figure 5). The majority of the ground surface surrounding the PRS was covered in vegetation duff, limiting visibility to between 10 and 25 percent. Open areas away from the PRS also contained dense vegetation, although visibility was slightly greater, ranging between 20 and 40 percent (see Figure 6). Sediments observed along the small terrace extending south from Carmel Valley Road consisted of light brown and tannish silty sands, appearing to be remnants of marine sandstone similar to that observed across Carmel Valley Road north of the project area.

A low-density scatter of marine shell remains was present along the south side of Carmel Valley Road, visible from approximately 50 feet east of the access road to approximately 250 feet east of the intersection of Carmel Valley Road and Portofino Drive (see Figure 7). The scatter consisted primarily of *Chione sp.*, *Argopecten sp.*, and *Ostrea sp.*, with several fragments of *Astrea sp.* observed. Very few fragments of the marine shell scatter were observed within areas surrounding the PRS or within the access road, however several fragments were observed along the south bank of the access road, suggesting that the previous grading and construction of the access road disturbed cultural elements that had formerly occupied the vicinity of the PRS. No additional prehistoric artifacts were observed. Several areas along the terrace crest contained rodent burrows, some which exhibited recent activity, and displaced sediments did not contain any presence of shell midden or evidence of potentially intact subsurface deposits.

No historic-era artifacts were observed during the survey effort, although numerous fragments of modern-era refuse and debris were present.

A review of historic imagery and topographic maps identified the remnants of a former historic-era railroad grade which proceeded through the eastern portion of Soledad Valley before turning west within the project area on its route to the Pacific coastline. A portion of the railroad was previously recorded as resource P-37-036419, outside of the project area. Although the aerial and topographic maps indicated that the railroad grade may have historically intersected the project area, the pedestrian survey was unable to identify any features or landform alteration associated with the former railroad. The historic imagery and map review also identified that the project area

had likely been graded between 1982 and 1983. No evidence of features or landform alterations associated with P-37-036419 were observed.

V. CONSTRAINTS ANALYSIS AND RECOMMENDATIONS

The record search identified that P-37-017122/CA-SDI-16653 was previously recorded within the project area, along portions of the access road from Carmel Valley Road to the PRS. The archaeological survey conducted on April 22, 2021 confirmed the presence of the resource from approximately 50 feet east of the access road to approximately 250 feet east of Portofino Drive. The current survey effort identified a shell scatter but did not identify any additional cultural artifacts. The survey effort did not observe any indications of potentially intact subsurface deposits within the project area. Additionally, no visual evidence of grade beds, landform terracing, or other features associated with P-37-036419 were observed.

Ground disturbance within and near the boundaries of P-37-017122/CA-SDI-16653 could constitute a significant impact under CEQA and would require mitigation. Mitigation would likely consist of data recovery excavations, sampling the impacted area, as well as construction monitoring. If ground disturbance is required within the boundaries of P-37-017122/CA-SDI-16653, including vegetation removal that causes ground disturbance, then additional archaeological testing and site evaluation will be required.

It is recommended that no vegetation removal or grading of the access road take place, and that heavy equipment with rubber tires only and no equipment with tracks be used, to avoid any impacts to P-37-017122/CA-SDI-16653 within the access road. Any required vegetation removal, should be conducted above the surface of the soil.

Archaeological and Native American monitoring is recommended during all work due to the presence of the prehistoric cultural resource within and adjacent to the project area.

Additional excavation work beyond the scope of the proposed project plan will require additional archaeological work to assess the potential for subsurface deposits.

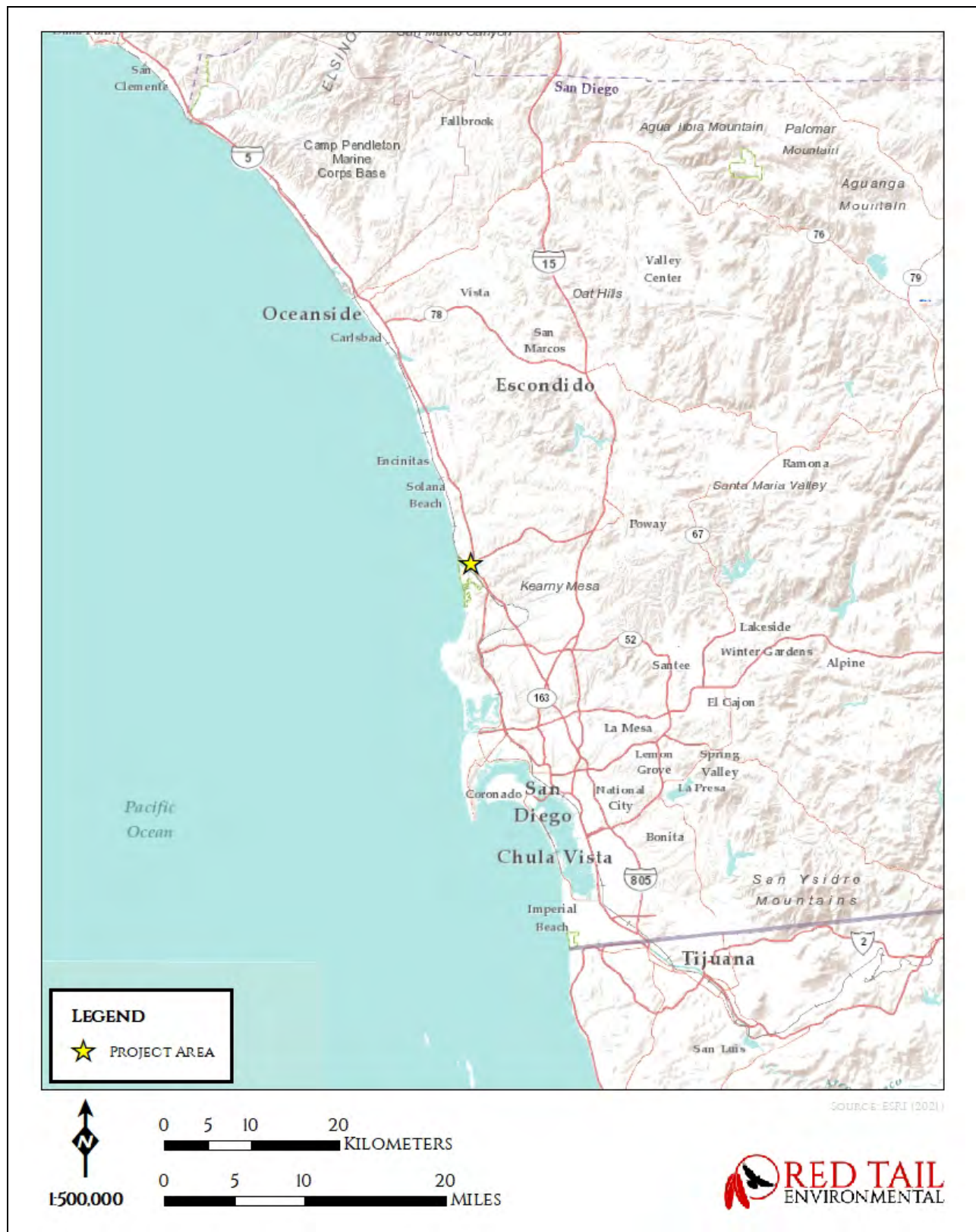


Figure 1. Project Vicinity Map

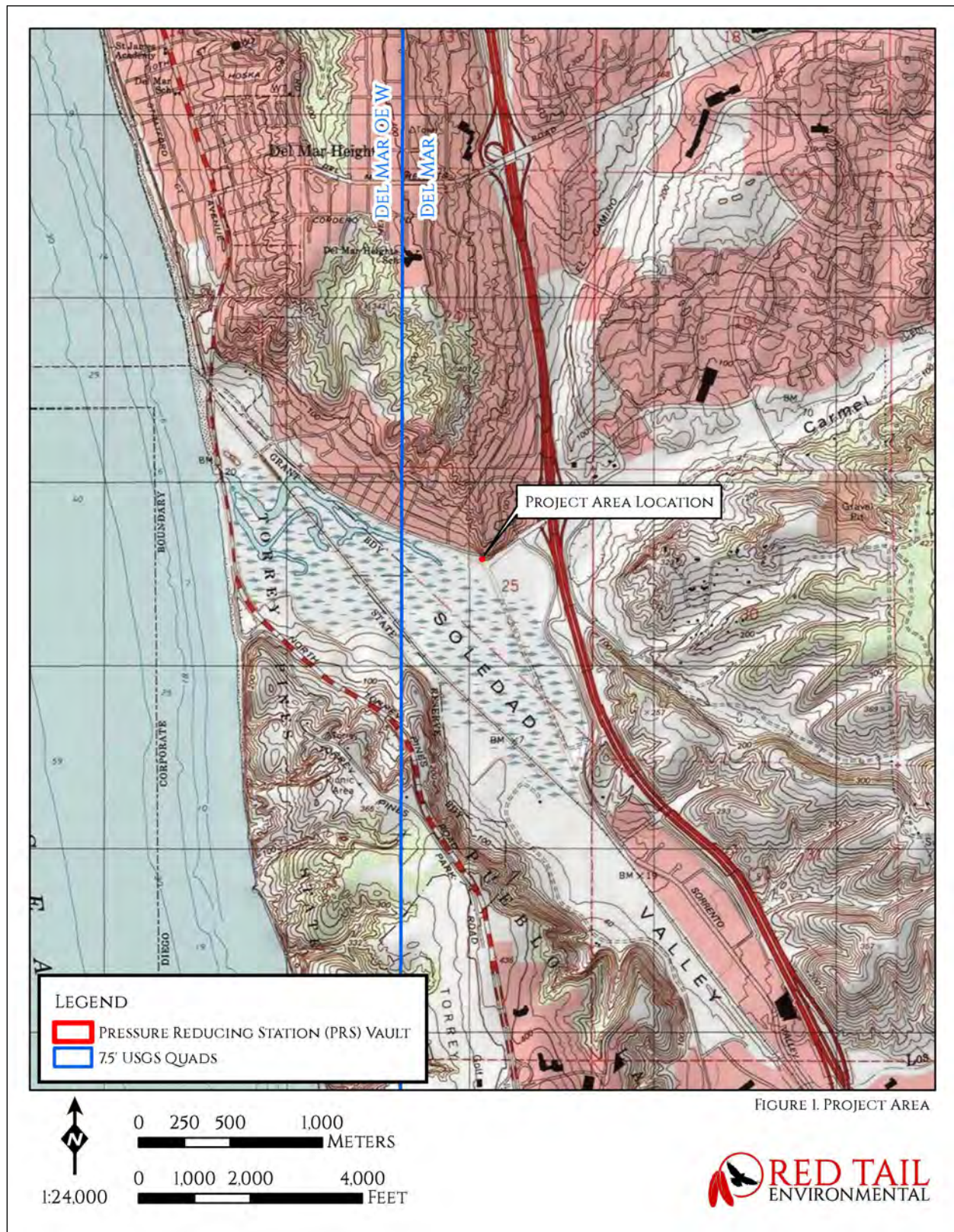




Figure 6. Overview of Access Road leading to Carmel Valley Road, facing east-northeast.

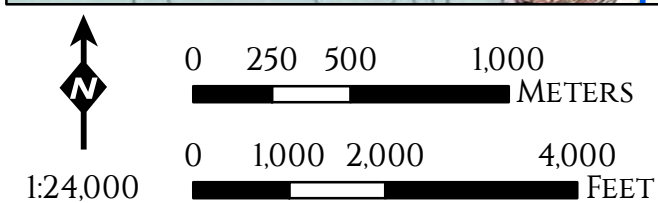
