HRB-17-065 HEARING DATE: October 26, 2017 ITEM #11 - South Park Historic District (2nd Hearing) SUBJECT: **RESOURCE INFO:** California Historical Resources Inventory Database (CHRID) link **APPLICANT:** City of San Diego Planning Department LOCATION: Various addresses within the intensive survey area, which is bounded roughly by 28th Street to the west, Elm Street to the north, 31st Street to the East and A Street to the south (excluding 3017-3091 Elm Street, 1635 and 1639-1747 Fern Street, 1634-1729 Grove Street, 1670-1740 31st Street, and the Albert Einstein Charter Academy); Golden Hill Community, Council District 3 **DESCRIPTION:** Review the South Park Historic District nomination; consider the level of owner support for the establishment of the district; and designate the South Park Historic District with identified contributing and non-contributing resources, or do not designate the South Park Historic District.

STAFF RECOMMENDATION

At this time, staff recommends that the Board:

- 1. Designate the South Park Historic District under HRB Criterion A as a special element of Golden Hill's historical and architectural development.
- 2. Designate the 295 Contributing Resources identified in the Draft Resolution (Attachment 1) under HRB Criterion F.
- 3. Classify the 112 properties identified in the Draft Resolution (Attachment 1) as Non-Contributing Resources to the District.

This recommendation is based on the following finding:

 The South Park Historic District is significant under HRB Criterion A as a special element of the City and Golden Hill's historical and architectural development. Specifically, the district is representative of real estate and streetcar suburban development in the first half of the 20th century, which is an important aspect of the historical and architectural development of Golden Hill. Contextually, the district relates to real estate marketing and the construction of infrastructure that accelerated development in the South Park neighborhood of Golden Hill by 1906; and it relates to the variety and evolution of architectural styles and trends in the pre-1950 period in San Diego represented in a range of socio-economic expressions, some of which were designed and built by Master Architects and Builders. The degree of integrity exhibited by the district contributors makes it one of the best unified examples of an early 20th century streetcar suburb in the community. In addition to the buildings, the South Park District is further unified by Mexican Fan Palm trees lining many of the streets and sidewalks of the subdivision. The period of significance begins with the initial development of South Park in 1906 and ends with the general build-out of the district and decommissioning of the streetcar in 1949.

BACKGROUND

This item to designate the South Park Historic District is being brought before the Historical Resources Board by the City of San Diego Planning Department consistent with SDMC Section 123.0303 and HRB Policy 4.1 on Establishing Historical Districts, last amended on October 27, 2011 (District Policy). The South Park Historic District is located in the South Park neighborhood of Golden Hill, and is comprised of 407 built resources on 396 parcels (including two vacant parcels). The district is bounded roughly by 28th Street to the west, Elm Street to the north, 31st Street to the east, and A Street to the south, excluding areas at the northeast corner, and the Albert Einstein Charter Academy at the south, as shown on the district map. The South Park Historic District was identified in the 1996 Mid-City Survey and the 2016 Golden Hill Community Plan Area Historic Resources Survey, prepared in support of the comprehensive Community Plan Update (CPU) for Golden Hill.

First Hearing

On September 28, 2017 the Board held the first hearing for the South Park Historic District where the nomination was reviewed, deemed complete and forwarded to a second hearing for designation. The staff report provided for the hearing is included as Attachment 2. As the hearing, several members of the public, including the Save Our Heritage Organisation (SOHO) spoke in favor of extending the period of significance through 1949 to capture the decommissioning of the streetcar and the end of the streetcar era in Golden Hill. Additionally, SOHO presented a list of 41 properties that they felt should be re-classified from Non-Contributing to Contributing. Following extensive discussion of the period of significance and the impact of asbestos shingle siding on the integrity of a building and its ability to convey the significance of the district, the Board took the following actions:

- 1. Accepted the proposed South Park Historic District boundary.
- 2. Accepted the proposed South Park Historic Context.
- 3. Accepted the proposed Statement of Significance, with direction to revise it to address the expanded period of significance through 1949.
- 4. Accepted the Period of Significance of 1906-1930, with direction to extend it through 1949 to incorporate the end of the streetcar era.
- 5. Consider the classification of 259 properties as Contributing Resources, as identified in the Staff Report, with direction to staff to review and strongly consider the properties in the SOHO list.

- 6. Consider the classification of 147 properties as Non-Contributing Resources, as identified in the Staff Report, with direction to staff to review and strongly consider the properties in the SOHO, and if the application of asbestos shingle siding is the primary reason for classification as non-contributing, then reclassify the property as contributing.
- 7. Find that the nomination is complete based upon this direction, and direct staff to docket the South Park Historic District nomination for a second HRB hearing for designation as a historic district.

<u>ANALYSIS</u>

Staff Response to Board Direction

Based upon direction given by the Board at the first hearing, staff completed minor edits to the context, statement of significance and period of significance, extending it from 1906-1930 to 1906-1949. The context and statement of significance now note that the district exhibits a range of architectural styles from "the first half of the 20th Century" as opposed to "the early decades of the 20th Century", and states that the period of significance "begins with the first development in South Park in 1906 and ends with the general build-out of the district and decommissioning of the streetcar in 1949" (Attachments 3 and 4). In addition, the Building, Structure and Object Record (DPR-B) form for all 407 surveyed properties was revised to reflect the revised period of significance and statement of significance (Attachment 5).

Once these minor revisions were complete, staff re-reviewed the 98 non-contributing resources built before 1931 to determine what modifications occurred within the expanded period of significance and which of those properties should be reclassified as contributing due to modifications that occurred between 1931 and 1949. Staff then reviewed the 22 properties built between 1931 and 1949 and classified those as contributing or non-contributing resources based upon integrity and ability to convey the significance of the district.

Lastly, staff reviewed the 41 properties on the SOHO list, all of which fell within one of the first two categories, and considered the input provided. Staff concurs with 24 of the reclassifications recommended by SOHO, and disagrees with the classification of 17. A detailed tabular analysis of the SOHO properties that includes the staff response or action, is included in Attachment 6. An additional 12 properties not identified by SOHO were reclassified by staff as contributing based upon the result of the staff analysis. In total, 36 properties previously classified by staff as non-contributing at the first hearing are now recommended for classification as contributing resources, as follows:

These revised classifications are reflected in the updated South Park Historic District Resource Analysis Spreadsheet provided as Attachment 7 and the updated South Park Historic District Map provided as Attachment 8.

Historical Significance of the Spalding Place Historic District

Based upon the historic context, the South Park Historic District is significant under HRB Criterion A as a resource that exemplifies and reflects special elements of Golden Hill's historical and architectural development.

In regard to historical development, the district is representative of the development of northern Golden Hill as a streetcar suburb in the early 1900s. When South Park was developed beginning in 1906, the northern area of Golden Hill was largely rural. The vision of the Bartlett Estate Company to develop a high class residential district necessitated the construction of extensive infrastructure improvements – including water, sewer, electricity, landscaping and transit – to draw prospective buyers and residents to this remote new area of the City. The promise of reliable, affordable transportation, access to utilities, and deed restrictions to protect property values and investments, coupled with high-end speculative development that embodied the spirit and vision of the subdivision enticed development at a slow but steady pace. Commercial development began to emerge along the trolley line, providing goods and services to local residents within walking distance of the trolley and their homes. The 1911 ground-breaking for the Panama-California Exposition

ignited a boom of construction Citywide that rippled through the South Park. Increased connectivity through extension of the trolley lines, coupled with housing demands from new residents and visitors alike resulted in a surge of development, including single family homes, low-density multi-family apartments and flats, and commercial. By 1930 the area was nearly built-out, with relatively few undeveloped parcels scattered throughout northern Golden Hill. These scattered parcels were largely developed intermittently throughout the Great Depression and during World War II. By the time the streetcar was decommissioned in 1949, the district was nearly entirely built-out.

In regard to architectural development, the South Park Historic District represents the full spectrum of architectural trends and preferences in the first half of the twentieth century, expressed at various socio-economic levels. By far and away, the most prevalent style represented is Craftsman, with 62% (percent) of the structures in the district exhibiting exclusively or primarily Craftsman styling. The South Park Historic District also reflects these styles across a broad socio-economic spectrum, from high-style, custom designed homes located prominently along the eastern boarder of Balboa Park, to multi-family apartments closer to the 30th Street trolley line and smaller working-class bungalows along and east of the trolley line. As such, the South Park Historic District is a unique microcosm of early 20th century housing in a streetcar suburb setting.

The period of significance for the South Park Historic District begins in 1906 with completion of the streetcar line, the initial marketing of the subdivision, and the sale and construction of the first properties within the district; and ends in 1949 with the general build-out of the district and the decommissioning of the streetcar.

Classification of Contributing and Non-Contributing Resources

A historic district is comprised of contributing and non-contributing resources – those that convey and contribute to the significance of the district and those that do not. Contributing resources are those resources that were built within the period of significance for the district (the period of time that reflects and captures the district's historic significance) and retain integrity to convey that significance. Non-contributing resources were either built outside of the period of significance, or have been so modified that they no longer retain integrity to convey the significance of the district.

The development patterns in South Park are somewhat unique. In instances where multiple, substantial buildings are present on a single parcel, each building has been evaluated and documented individually in CHRID, in the resource analysis spreadsheet, and in the staff recommendation. However, because designation occurs at the parcel level, if a contributing resource has been identified on a parcel, that parcel will be flagged as contributing when mapped, even if there are other non-contributing resources on the same parcel. The designation resolution, along with the DPR-A and DPR-B forms prepared for all properties, will guide property owners and staff on future treatment of parcels with multiple structures.

At the first hearing, staff recommended that 259 of the 406 resources in the district be classified as contributing resources and 147 resources be classified as non-contributing resources. As detailed in the discussion of the staff response to the Board's direction at the first hearing, the number of contributing and non-contributing resources has been revised. First, as a result of the additional analysis, the property at 1512-1514 31st Street, which contains two buildings, is now documented on two separate database entries and is counted as two separate resources, bring the total up to 407 total resources. Of the 407 resources in the district, 295 are recommended for classification as

contributing resources (72.5%), and 112 are recommended for classification as non-contributing resources (27.5%).

Staff conducted a site visit to the South Park Historic District on October 4th as part of the additional analysis following the September hearing. During this site visit, staff noted that the property at 2980 Cedar Street had undergone some recent alterations, including replacement of the wood shingle siding on the south elevation, and replacement of the wood windows at portions of the second floor with vinyl in the original openings. Review of permit applications reveal that this work was not permitted. Staff has contacted Code Enforcement to address the issue. In the meantime, the Board may consider the building in its condition and appearance prior to the unpermitted work.

Property Owner Support

While property owner consent to historic designation is not required by the municipal code, the District Policy requires staff to solicit the level of support and opposition from property owners within the proposed district boundary and provide that information to the Board. Following the property owner workshop, self-addressed stamped polling cards were mailed to property owners, who were asked to respond by September 12th. As of the date of this staff report, staff has received responses from 142 of the 395 private property owners within the district. Of the 142 responses, 104 are in support of the district designation (73% of respondents, 26% of total), 32 are opposed (23% of respondents, 8% of total), and 6 are neutral and have no position (4% of respondents, 2% of total).

Of the property owners in opposition, the property owner of 1301-1307 Fern Street/3034-3036 A Street be removed from the district through a boundary line adjustment, and the property owner at 1310 29th Street (constructed 1936) expressed his desire to be classified as non-contributing in light of the expanded period of significance. In regard to the former, staff does not support a boundary modification; and as to the latter, staff reviewed the property and is recommending classification as non-contributing due to a lack of integrity. Staff will update the Board at the October 26th hearing regarding owner support and opposition. All property owners received notice of the property owner workshop, the polling effort, the first hearing before the Historical Resources Board and the second hearing before the Board, and were provided links to all hearing materials.

CONCLUSION

At this time, staff recommends that the Board:

- 1. Designate the South Park Historic District under HRB Criterion A as a special element of Golden Hill's historical and architectural development.
- 2. Designate the 295 Contributing Resources identified in the Draft Resolution (Attachment 1) under HRB Criterion F.
- 3. Classify the 112 properties identified in the Draft Resolution (Attachment 1) as Non-Contributing Resources to the District.

Designation brings with it the responsibility of maintaining the building in accordance with the Secretary of the Interior's Standards. The benefits of designation as a Contributing Resource within the District include the availability of the Mills Act Program for reduced property tax; the use of the more flexible Historical Building Code; flexibility in the application of other regulatory requirements;

the use of the Historical Conditional Use Permit which allows flexibility of use; and other programs which vary depending on the specific site conditions and owner objectives.

RESOLUTION NUMBER R-171026XX.1 ADOPTED ON 10/26/2017

WHEREAS, the Historical Resources Board of the City of San Diego held a noticed public hearing on October 26, 2017 to consider the historical designation of the **South Park Historic District** (with various property owners as identified in the tables below) **located at various addresses within the Historic District boundaries**, which includes the 407 resources bounded roughly by 28th Street to the west, Elm Street to the north, 31st Street to the East and A Street to the south (excluding 3017-3091 Elm Street, 1635 and 1639-1747 Fern Street, 1634-1729 Grove Street, 1670-1740 31st Street, and the Albert Einstein Charter Academy), as identified in the table below and in companion resolutions R-171026XX.2 and R-171026XX.3 (on file with the City of San Diego Historical Resources Section); in the City of San Diego, County of San Diego, State of California; and

WHEREAS, in arriving at their decision, the Historical Resources Board considered the historic district nomination prepared by the applicant, the staff report and recommendation, all other materials submitted prior to and at the public hearing, inspected the historic district and heard public testimony presented at the hearing; and

WHEREAS, the South Park Historic District would be added to the Register of Designated Historical Resources as **Site No. XXXX**, and

WHEREAS, designated historical resources located within the City of San Diego are regulated by the Municipal Code (Chapter 14, Article 3, Division 2) as such any exterior modifications (or interior if any interior is designated) shall be approved by the City, this includes but is not limited to modifications to any windows or doors, removal or replacement of any exterior surfaces (i.e. paint, stucco, wood siding, brick), any alterations to the roof or roofing material, alterations to any exterior ornamentation and any additions or significant changes to the landscape/ site, for both contributing and non-contributing resources.

NOW, THEREFORE,

BE IT RESOLVED, the Historical Resources Board based its designation of the South Park Historic District with a period of significance of 1906-1949 on the following findings, which are further supported by the information in the staff report, the historical district nomination, and written and oral evidence presented at the designation hearing:

(1) The South Park Historic District is significant under HRB Criterion A as a special element of the City and Golden Hill's historical and architectural development. Specifically, the district is representative of real estate and streetcar suburban development in the first half of the 20th century, which is an important aspect of the historical and architectural development of Golden Hill. Contextually, the district relates to real estate marketing and the construction of infrastructure that accelerated development in the South Park neighborhood of Golden Hill by 1906; and it relates to the variety and evolution of architectural styles and trends in the pre-1950 period in San Diego represented in a range of socio-economic expressions, some of which were designed and built by Master Architects and Builders. The degree of integrity exhibited by the district contributors makes it one of the best unified examples of an early 20th century streetcar suburb in the community. In addition to the buildings, the South Park District is further unified by Mexican Fan Palm trees lining many of the streets and sidewalks of the subdivision.

BE IT FURTHER RESOLVED, that the following 200 properties, along with the 95 properties identified in companion resolution R-171026XX.2, have been identified as Contributing Resources to the South Park Historic District and shall be designated under HRB Criterion F. These properties will be subject to the U.S. Secretary of the Interior's Standards, the City of San Diego Historic Resources

Regulations, and any applicable development and design guidelines as they relate to Contributing Resources, and will be eligible for all benefits of historic designation:

# RESOLUTION NUMBER R-171026XX.2 ADOPTED ON 10/26/2017

WHEREAS, the Historical Resources Board of the City of San Diego held a noticed public hearing on October 26, 2017 to consider the historical designation of the **South Park Historic District** (with various property owners as identified in the tables below) **located at various addresses within the Historic District boundaries**, which includes the 407 resources bounded roughly by 28th Street to the west, Elm Street to the north, 31st Street to the East and A Street to the south (excluding 3017-3091 Elm Street, 1635 and 1639-1747 Fern Street, 1634-1729 Grove Street, 1670-1740 31st Street, and the Albert Einstein Charter Academy), as identified in the table below and in companion resolutions R-171026XX.1 and R-171026XX.3 (on file with the City of San Diego Historical Resources Section); in the City of San Diego, County of San Diego, State of California; and

WHEREAS, in arriving at their decision, the Historical Resources Board considered the historic district nomination prepared by the applicant, the staff report and recommendation, all other materials submitted prior to and at the public hearing, inspected the historic district and heard public testimony presented at the hearing; and

WHEREAS, the South Park Historic District would be added to the Register of Designated Historical Resources as **Site No. XXXX**, and

WHEREAS, designated historical resources located within the City of San Diego are regulated by the Municipal Code (Chapter 14, Article 3, Division 2) as such any exterior modifications (or interior if any interior is designated) shall be approved by the City, this includes but is not limited to modifications to any windows or doors, removal or replacement of any exterior surfaces (i.e. paint, stucco, wood siding, brick), any alterations to the roof or roofing material, alterations to any exterior ornamentation and any additions or significant changes to the landscape/ site, for both contributing and non-contributing resources.

# NOW, THEREFORE,

BE IT RESOLVED, the Historical Resources Board based its designation of the South Park Historic District with a period of significance of 1906-1949 on the following findings, which are further supported by the information in the staff report, the historical district nomination, and written and oral evidence presented at the designation hearing:

(1) The South Park Historic District is significant under HRB Criterion A as a special element of the City and Golden Hill's historical and architectural development. Specifically, the district is representative of real estate and streetcar suburban development in the first half of the 20th century, which is an important aspect of the historical and architectural development of Golden Hill. Contextually, the district relates to real estate marketing and the construction of infrastructure that accelerated development in the South Park neighborhood of Golden Hill by 1906; and it relates to the variety and evolution of architectural styles and trends in the pre-1950 period in San Diego represented in a range of socio-economic expressions, some of which were designed and built by Master Architects and Builders. The degree of integrity exhibited by the district contributors makes it one of the best unified examples of an early 20th century streetcar suburb in the community. In addition to the buildings, the South Park District is further unified by Mexican Fan Palm trees lining many of the streets and sidewalks of the subdivision.

BE IT FURTHER RESOLVED, that the following 95 properties, along with the 200 properties identified in companion resolution R-171026XX.1, have been identified as Contributing Resources to the South Park Historic District and shall be designated under HRB Criterion F. These properties will be subject to the U.S. Secretary of the Interior's Standards, the City of San Diego Historic Resources

Regulations, and any applicable development and design guidelines as they relate to Contributing Resources, and will be eligible for all benefits of historic designation:

RESOLUTION NUMBER R-171026XX.3 ADOPTED ON 10/26/2017

WHEREAS, the Historical Resources Board of the City of San Diego held a noticed public hearing on October 26, 2017 to consider the historical designation of the **South Park Historic District** (with various property owners as identified in the tables below) **located at various addresses within the Historic District boundaries**, which includes the 407 resources bounded roughly by 28th Street to the west, Elm Street to the north, 31st Street to the East and A Street to the south (excluding 3017-3091 Elm Street, 1635 and 1639-1747 Fern Street, 1634-1729 Grove Street, 1670-1740 31st Street, and the Albert Einstein Charter Academy), as identified in the table below and in companion resolutions R-171026XX.1 and R-171026XX.2 (on file with the City of San Diego Historical Resources Section); in the City of San Diego, County of San Diego, State of California; and

WHEREAS, in arriving at their decision, the Historical Resources Board considered the historic district nomination prepared by the applicant, the staff report and recommendation, all other materials submitted prior to and at the public hearing, inspected the historic district and heard public testimony presented at the hearing; and

WHEREAS, the South Park Historic District would be added to the Register of Designated Historical Resources as **Site No. XXXX**, and

WHEREAS, designated historical resources located within the City of San Diego are regulated by the Municipal Code (Chapter 14, Article 3, Division 2) as such any exterior modifications (or interior if any interior is designated) shall be approved by the City, this includes but is not limited to modifications to any windows or doors, removal or replacement of any exterior surfaces (i.e. paint, stucco, wood siding, brick), any alterations to the roof or roofing material, alterations to any exterior ornamentation and any additions or significant changes to the landscape/ site, for both contributing and non-contributing resources.

NOW, THEREFORE,

BE IT RESOLVED, the Historical Resources Board based its designation of the South Park Historic District with a period of significance of 1906-1949 on the following findings, which are further supported by the information in the staff report, the historical district nomination, and written and oral evidence presented at the designation hearing:

(1) The South Park Historic District is significant under HRB Criterion A as a special element of the City and Golden Hill's historical and architectural development. Specifically, the district is representative of real estate and streetcar suburban development in the first half of the 20th century, which is an important aspect of the historical and architectural development of Golden Hill. Contextually, the district relates to real estate marketing and the construction of infrastructure that accelerated development in the South Park neighborhood of Golden Hill by 1906; and it relates to the variety and evolution of architectural styles and trends in the pre-1950 period in San Diego represented in a range of socio-economic expressions, some of which were designed and built by Master Architects and Builders. The degree of integrity exhibited by the district contributors makes it one of the best unified examples of an early 20th century streetcar suburb in the community. In addition to the buildings, the South Park District is further unified by Mexican Fan Palm trees lining many of the streets and sidewalks of the subdivision.

BE IT FURTHER RESOLVED, that 295 properties listed in companion resolutions R-171026XX.1 and R-171026XX.2 have been identified as Contributing Resources to the South Park Historic District and shall be designated under HRB Criterion F. These properties will be subject to the U.S. Secretary of the Interior's Standards, the City of San Diego Historic Resources Regulations, and any applicable
development and design guidelines as they relate to Contributing Resources, and will be eligible for all benefits of historic designation.

BE IT FURTHER RESOLVED, that the following 112 properties have been identified as Non-Contributing Resources to the South Park Historic District. These properties will be subject to the U.S. Secretary of the Interior's Standards, the City of San Diego Historic Resources Regulations, and any applicable development and design guidelines as they relate to Non-Contributing resources:
