Motion Approved By Uptown Planners on October 2, 2018:

Uptown Planners discussed the proposed amendments to the City of San Diego's Historic District Formation process at its October 2, 2018 meeting. Public comment was made by eight individuals. The board of Uptown Planners passed the following motions:

- 1. Uptown Planners supports the Historic Review Board guideline amendments related to increased noticing for the establishment of new Historical Districts: Motion passed by 15-1-1, with non-voting chair abstaining
- 2. Uptown Planners does not support amendments changing the decision maker to the Planning Commission, and for any appeal to trigger a de novo hearing; Motion passed by 14-2-1, with non-voting chair abstaining.

<u>AD HOC SUBCOMMITTEE MOTION 1</u>: The Joint North Park Subcommittee/Uptown Planners Historic Resources Committee supports HRB guideline amendments related to increased noticing for the establishment of new Historical Districts as outlined in July 9, 2018 HRB Policy Subcommittee Memorandum. Carlson/Dahl 8-0-0.

<u>AD HOC SUBCOMMITTEE MOTION 2</u>: The Joint North Park Subcommittee/Uptown Planners Historic Resources Committee does not support amendments that will weaken the current historical district ordinance including changing the decision maker from the City Council to the Planning Commission and for any appeal to trigger a de novo hearing.
