- <u>Staff Recommendation</u>: Designate the Ralph Ward House located at 4239 Palmetto Way as a historical resource with a period of significance of 1914 under HRB Criterion C. The designation excludes the garage and the rear second floor addition constructed in 1929. The designation includes the living room fireplace with flanking bookshelves, study fireplace, dining room buffet and living room window seat.
