SUBJECT: Adoption of the Transportation & Storm Water Design Manual

Effective on July 1, 2017, the City of San Diego shall adopt the Transportation & Storm Water Design Manual.

The standards shall be enforced beginning **January 1, 2018**. All permits issued on or after said date shall comply with the newly adopted standards. Once adopted, the documents and standards may be found for your reference at the following links:

In the meantime, between the adoption date and the enforcement date, this period will provide professionals time to become familiar with the changes to consider into future projects, as they may apply. Projects starting reviews within this period will need to consider the timing of receiving permit approval/issuance. Should the project be approved on or after January 1, 2018, it will be approved in conformance with the adopted standards.

SUBJECT: Adoption of the City of San Diego Transportation & Storm Water Design Manual

Effective July 1, 2017, the City of San Diego will adopt the Transportation & Storm Water Design Manual, which consists of updated editions of the Street Design Manual and Drainage Design Manual that have been combined into one document. The combined manual will provide technical guidelines to assist professional engineers in design of both transportation and storm water facilities.

All Capital Improvement Program (CIP) projects that have plans signed by professional engineers before January 1, 2018 may comply with the current editions of the Street and Drainage Design Manuals or use the combined Transportation & Storm Water Design Manual. Projects with plans signed by professional engineers on or after January 1, 2018 must be designed in accordance with the combined Transportation & Storm Water Design Manual.
