The CRC is responsible for redrawing Congressional, State Senate and Assembly, and Board of Equalization district boundaries once every 10 years using data collected from the Decennial Census. It is redistricting at the state level. The Commission is in the final line drawing phase and looking for feedback on map visualizations and collecting Community of Interest Public Input. While the Commission has heard broadly from some communities around San Diego, they lack some input from our area.
