City, County, and State Representatives' Reports

- Jawad Al Baghdadi Congresswoman Sarah Jacobs' office: Advocacy for local residents in terms of federal programs is available and root for the Padres.
- Bruce Williams Community Representative for District 4, Council President pro Tem Monica Montgomery-Steppe: Cannabis equity assessment funds information was provided, T-Mobile Cell Tower City Council Appeal was postponed until November 1.
- Naveed Haris, Community Representative for District 9, Council President Sean Elo-Rivera: The eviction moratorium has expired, there are housing protection resources available. Budget priority memo will be made available, homelessness resources are available.

Presentation on the Oak Park Library Project

Monica Arredondo, Project Manager for City of San Diego, Engineering & Capital Projects: The current 5,200 sq. ft. building (1969) to be replaced with a 20,000 sq. ft. facility nearby with an estimated budget of \$21M. Community input will be a part of the design evaluation. Several suggestions were offered from those in attendance.

Treasurer's Report – Derryl: \$75 in the bank; donations accepted in case we need to rent a space and/or buy donuts in the future.

Approval of Minutes (August and September): Edits to both documents were requested by committee members; Daniele moved to approve with corrections, Derryl seconded; the minutes were approved unanimously as corrected.

- Community updates: Alex, El Cerrito, reported that a discussion on Measure B was coming up at the next community meeting; Richard Diaz, for Oak Park, working on funding for putting up banners; Bob Scott, for Rolando, had a successful event at Dog Society on University Ave; Derryl, for Webster, said that an approach to the Coca Cola facility is being made. It's an institutional look and that's not ideal. The pocket park being planned for Home & Federal was also discussed. Lynn reported that Rolando Park had a hybrid meeting that went fairly well.
- University Ave Bob: a site walk is upcoming with the District 9 rep.
- Parks & Recreation Daniele: there will be a special meeting to go over the dog park concept for Colina. There is a new board for the little league.
- Transportation Bike Lanes: Mario discussed the free MTS day that just passed.
- CPC September Meeting Lynn reported that land development code updates were acted upon; more concerns were voiced about the free CPG appeals being lost.
