**Councilmember Todd Gloria**

Friends,

As part of my commitment to a strong dialogue with the community, I am writing today about several items of importance and upcoming events. I am a better Councilmember because of your suggestions and questions, and welcome your input on these and any other City-related matters.

As I have stated since before I was sworn in and as has been well-covered by the media, the City of San Diego's finances are not in the best position. To deal with our immediate deficit, City employees just agreed to huge reductions to their compensation, many fees the City charges for service were finally adjusted to be fully cost-recoverable, and some reserve funds will be used. While I am relieved that no recreation centers or libraries are slated to be closed due to budget shortfalls, I cannot be content with our ongoing structural budget deficit.

In recognition of the sacrifices accepted by City employees and of the financial position of the City of San Diego, I will take a 6% pay cut in Fiscal Year 2010.

I fully recognize the sacrifices we asked of our hard-working employees, and took action to ensure my office budget reflected a similar forfeit and was made as efficient as possible. We were given the same directive as City departments to cut 6% in labor costs from our already-tight budgets, and I am proud to say that we have reduced salaries overall by approximately 8% and reduced fringe benefits expenditures by close to 4% in FY 2010. Since entering office, I have also declined to accept the auto allowance, saving the City an additional \$9,600 per fiscal year.

In addition, because informational technology services were decentralized citywide, our office budget was also forced to absorb a 114% increase in non-discretionary contracts, from \$26,600 in FY 09 to \$56,999 in FY 10. Even with this significant jump, I am proud that my office's bottom-line budget is still lower than in previous fiscal years.

Careful budgeting with lower staff salaries and tightening of plans for supplies and services should allow for us to accumulate savings by the end of the year which will be used for neighborhood services, to be determined depending on community priorities and available funds.

These cuts were not easy. Like employees throughout the City, my staff works incredibly hard to help me serve the public. I am proud we are doing our part to address the City's budget shortfalls, and look forward to working with my colleagues, our employees and all San Diegans to provide a permanent fix to our structural budget deficit.

### **Can Balboa Park be Greener?**

Today I joined Mayor Jerry Sanders in Balboa Park to announce a proposal to dedicate \$5 million of federal energy efficiency and conservation stimulus dollars to Balboa Park. This exciting plan will connect the \$5 million of federal funds to a \$25 million investment by SunEdison to install and maintain three megawatts of solar power at Balboa Park for 20 years, making the park more efficient, reducing greenhouse gases, getting us closer to energy independence, and adding needed quality jobs for San Diegans. The entire \$12.5 million energy efficiency and conservation stimulus spending plan will be reviewed at public hearings in the upcoming month, and your participation is encouraged.
